Search started at 1700 hrs 14/06/2025 and completed at 1755 hrs on 14/06/2025

Acting on an specific information based on a reliable source, and taken down in writing and submitted to immediate superior officer Sh. Aram Anth, Supdt, NCB Imphal Zonal Unit by Sh. Prashant Kumar Yadav SI/Jr.Intelligence officer about the illegal storage of Methamphetamine at the house premise located at Thingkangphai village of Churanchandpur and thereafter in pursuance of the office order file no 01/20/SP-OF-OR/NCB/IMP/13/Vol-III dated 14.06.2025, a team of NCB imphal as detailed in the movement order left for the Churachandpur at around 1400 pm and at around 1530 team reached 37 Assam Rifles(Bn) HQ. On reaching Hqrs NCB Imphal Zonal Unit met Major Yadu Krishnan PS and gave a requisition letter to him for their assistance requesting to conduct house search and provide 02 Independent Witness. At around 1600Hrs NCB team along with a team of Assam Rifles led by Major Yadu Krishnan PS comprising 03 Rifle Women proceed for the Premiselocated at Thingkangphai village of Churanchandpur and reached said village at around 1620 hrs.

Sh. Prashant Kumar Yadav, SI/Jr.Intelligence officer introduced himself and rest of the team to IW and disclosed the secret information available with him.

Thereafter NCB team alongwith Assam rifles and IW reached the said premise of one Haopu Baite, r/o of Thingkangphai village of Churanchandpur when the team reached the

house premises, there were 02 rooms in the house and the two(02) persons were found sitting on the dining table which was to the left side of the common room. The NCB team then introduced themselves as well as the two independent witnesses to the 02 persons present at the premise, who, on asking introduced themselves as Mr Thangsuani (32 yrs) resident of Sangalkot, Churachandpur & Mr Seikhanhau Tunngung (22 yrs). On further asking if anyone else was present in the house, they stated that, they were the only ones and the owner of the house had gone out for some personal work and also stated that they were waiting for the owner of the House Haapu Baite to take their shares of Methamphetamine/Wy tablets from him. The team then disclosed the specific information available with them to the 02 persons and expressed their intention to search the premises. Before conducting the search of the house, the search of the team members as well as the two witnesses was also offered to the persons present there to which they refused. Thereafter the search of the residential premise of Haapu Baite was commenced at about 1700hrs on 14.06.2025 in the presence of the two independent witnesses and the two persons present in the house. During the search of the common room, 06 small blue coloured packets containing suspected methamphetamine, 02 small pink coloured packets containing suspected methamphetamine, 01 Pistol with magazine along with 04 live rounds, 01 Mobile (Model - Redmi note 8 pro), 01 Mobile (Model - iPhone 6 s), 01 Mobile (Model - one plus CE Nord 4), 01 Mobile (model- Redmi) which is inactive/broken were recovered from the dining table and on search of the second room One Brown/Pink Colour packet containing suspected methamphetamine, one brown/cream colour packet containing suspected methamphetamine was recovered from the secret chamber of the wardrobe. The packets suspected to contain methamphetamine were opened and small quantity from each packet were taken out and tested separately with drug detection kit available with NCB team which responded positive for the presence of Methamphetamine.



On reasonable belief that offence has been committed u/s 8c, 22c, 25 and 29 of NDPS act 1985 all the packets of Methamphetamine/WY tablets, items of the suspected persons were seized u/s 42 of the NDPS act 1985. One Pinkish/Cream colour packet marked as "P1", One brownish/cream colour packet marked as "P2", since the mode of packaging weight and contents and texture of the 06 blue colour packets of the substance believed to be methamphetamine were similar therefore bunched into (01) one lot as "P3" and two pink colour packets as one (01) lot as "P4". The Plastic packet of the substance believed to be Methamphetamine/WY tablets were Marked as "P1", "P2", "P3", "P4" as Search culminated by 1755 hrs and Mr Thangsuani (32 yrs) resident of Sangalkot, Churachandpur & Mr Seikhanhau Tunngung (22 yrs) resident of Zoumunnuam village, Churachandpur were apprehended. Thus the total gross weight of the contraband was found to be 1500 grms. Subsequently all the packets were wrapped in a white marking cloth Marked as B1 and sealed with brass seal NCB Imphal 01, properly labeled and then signed by the seizing officer, the two independent witnesses and the suspected person present there.

The following items/documents which were recovered as mentioned in the table above were also seized and labeled properly and signatures of the owners of the goods, seizing officer and 02 IW were taken. Videography and photography of the search and seizing proceedings was done as per law.

A search cum seizure procedure was completed about 1755 hrs on 14.06.2025 without causing any damage to any person or property in presence of the 02 IW. A search-cum-seizure list was prepared on the spot by Seizing officer and the signature of the owner of the seized goods, 02 IWs and seizing officer were obtained.

The impression of the brass seal NCB Imphal 01 was affixed on the last page of search cum seizure list. Contents of search cum seizure list was read over and explained to Mr Thangsuanlal (32 yrs) and Mr Seikhanhau Tunngung (22 yrs).

A copy of search cum seizure list was also handed over to them, the search procedure was completed peacefully without hurting any religious sentiments after following all legal formalities. Then the seizing officer handed over <sup>67</sup> notices to the 02 suspect for appearance before the investigation officer at nearest Assam Rifles post.

Further due to inconveniences and security reason and also due to present law and order situation and prevailing ethnic crisis and president rule in Manipur, the team look out for any other presence of person in and around the places and premises however no one was available during the time. Hence the team move out to the nearest Assam Rifles checkpoint without losing anytime for safety and security.

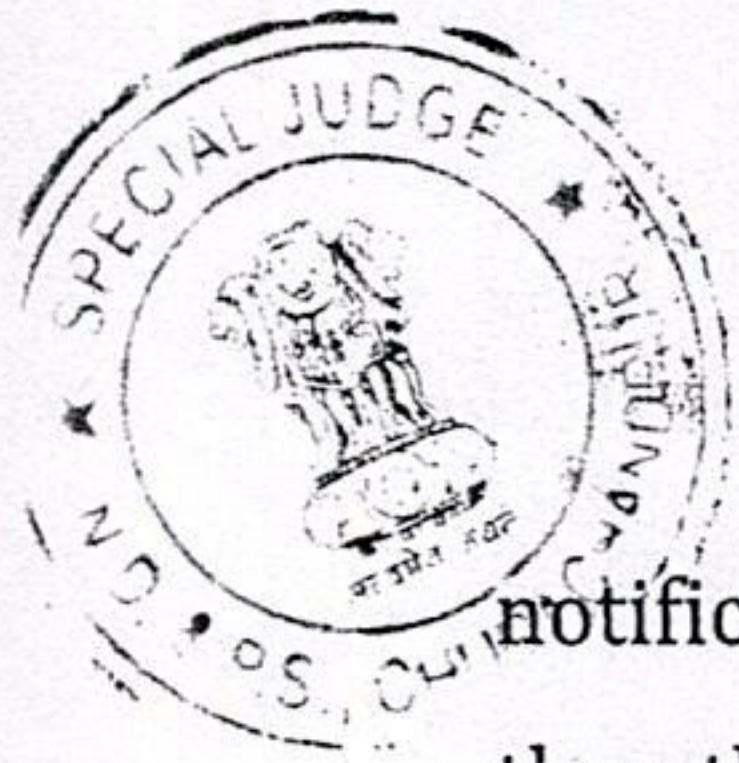
This is to dispose of the application filed on behalf of the petitioner Shri Virender, Investigating Officer cum Sub-Inspector, NCB, Imphal by the Special P.P, NCB praying for allowing the petitioner to hand over the seized Arms and Ammunitions in c/w NCB Crime No. 02/NCB/Imp/METH/2025, dated 14/06/2025 Under Section 8(c), 22(c), 25 & 29 of the ND&PS Act, 1985 (As amended) to the Churachandpur P.S for investigation.

The brief facts of the case is that the NCB Imphal Sub-Zone has effected a seizure of 1.5 Kgs of WY Tablets believed to be Methamphetamine on 14-06-2025





and other documents, INR currency, Mobile phones etc. from the house premises of Houpu Baite @ Jamhao. In connection with the recovery, the accused persons Thangsuanlal and Seikhanhau Tungnung were arrested on 15-06-2025. Apart from the Metamphetamine tablets, the following arms were also recovered – (i) Silver/blue Coloured Pistol and; (ii) Four live rounds. As the NCB, Imphal is not empowered to investigate non-narcotics items, hence the instant prayer for handing over the seized arms and ammunitions to the Churachandpur PS.



Heard the Id. Special P.P, NCB and perused the application.

It is evident that neither the scheme of the ND&PS Act of 1985 nor the notifications issued thereunder empowered the NCB to investigate offences other than those arising out of the ND&PS Act, 1985. As such, I am inclined to allow the prayer of the petitioner.

In the result, the prayer of the petitioner for handing over of the Silver/blue coloured pistol and 4 live rounds seized in connection with NCB Crime No. 02/NCB/Imp/METH/2025, dated 14/06/2025 Under Section 8(c), 22(c), 25 & 29 of the ND&PS Act, 1985 (As amended) to the Churachandpur P.S for investigation is allowed. The same shall be handed over in accordance with rules and procedures prescribed by law.

On 14.06.2025 NCB Imphal seized 1.5 kgs of Methamphetamine/WY tablets in which 02 accused person namely i)Thangsuanlal, age about 32 years S/O Kamzakap, r/ Vill-Sangaikot, Churachandpur sub-division, Churachandpur, Manipur-795128 bearing Aadhar No.-379878169255.

ii) Mr. Seikhanhau Tungung 23 yrs S/O Khupkhanlal Tungnung, R/o ; Zoumunnuam Village, Churachandpur Sub-Division, Churachandpur, Manipur-795128 were arreseted on 15.06.2025.

In the said case one Silver/blue Coloured Pistol with Magazine and four live rounds were also seized. As the NCB is not empowered to investigate offences other than those arising out of the ND&PS Act, 1985. So a petition was filed in NDPS court Churachandpur for Handing over the seized arms to concerned police station for further investigation.

On 07.07.2025 ND&PS court Churachandpur passed order (copy enclosed) to Handing over the Silver/blue Coloured Pistol and four live rounds in c/w NCB Crime no. 02/NCB/IMP/METH/2025 to Churachandpur Police Station for further investigation.

Hence, In compliance of the H'ble court order, the Arms, Magazine and ammunition be handed over for further necessary action.
