Police recce teams were readied to observe accumulation of women in the neighbourhood and RAF (including some women personnel) was also asked to move. On reaching the spot, it was observed that multiple trees had been cut down on the road leading to the village and trenches dug up to obstruct movement. The combined team led by SP-CCP moved on foot to the area and bypassed the crowd through the forested area to reach the village of S.Molhoi. The womenfolks numbering about 200-300 attacked, shoved, manhandled the security personnel by using force, in which some security personnel sustained biting injuries. Since the accused person could not be sighted, it is being assumed that the suspected person somehow managed to escaped with the help of womenfolks dressed in women's clothes during the confrontation.


