As endorsed I have made an enquiry on the report submitted by Ms. Niengfelzou (27) years d/o Kamtinlal Gangte of Gangte veng, CCPur # 9612499883 regarding Fraud through G-Pay, stating that on the 10<sup>th</sup> July, 2025 at around 04:30 PM, one unidentified male riding in black Bullet with no registration number plate wearing white T-Shirt and black pant, good physique and smart looking using Thadou dialect went to her shop located at Gangte veng, near Saviour's Public School, Lamka and asked her if there is any Mini-ATM in the area. She told him that there is no Mini-ATM nearby and he asked her a sum of Rs. 4000/- in cash and he would transfer it through G-Pay. However, at that moment she did not have Rs.4000/- in cash and asked her Rs.3000/- so she gave him Rs.3000/- in cash along with 2 litres of Petrol (Rs.240/-). After she gave the cash along with 2 litres of Petrol he told her that he had paid the sum of Rs.3250/- through G-Pay (Rs.10/- extra). On checking her phone she found out that he has not made any payment and have cheated her.

Enquiry was made into the matter and the same was found genuine. On 15<sup>th</sup> July, 2025 at around 06:30 PM, received a reliable information from source that 02(two) unidentified persons were apprehended/detained by S.Kotlian villagers, who had done committing fraud cheating at Kangvai village, CCPur. As per information received, immediately, Self along with police party of CCP-PS, assisted by SI Thianminboi Vaiphei, 2<sup>nd</sup> OC/CCP-PS rushed to S.Kotlian village and reached the spot. On preliminary examination by the villagers of S.Kotlian, they had committed cheating and inducing delivery of property to one unknown Lady proprietor of one shop located at Kangvai village, CCPur and succeed. The two unidentified male were handed over to the police team and they were brought to CCP-PS for further verification.

On thorough enquiry, the 02(two) individual were identified as 1. L.Seiminlal Haokip (34) years s/o Seikhomang Haokip of P.Laijang village, Churachandpur and 2. Lunkhomang Haokip (40) years s/o Thangjangam of Songja Khopi, Churachandpur. On interrogation, the accused namely, L.Seiminlal Haokip (34) years s/o Seikhomang Haokip of P.Laijang village, Churachandpur admitted to the crime he had committed on the 10<sup>th</sup> July, 2025 at around 04:30 PM at Gangte veng, near Saviour's Public School, Lamka in c/w GD No.17/CCP-PS/2025 Dated:15/07/2025. 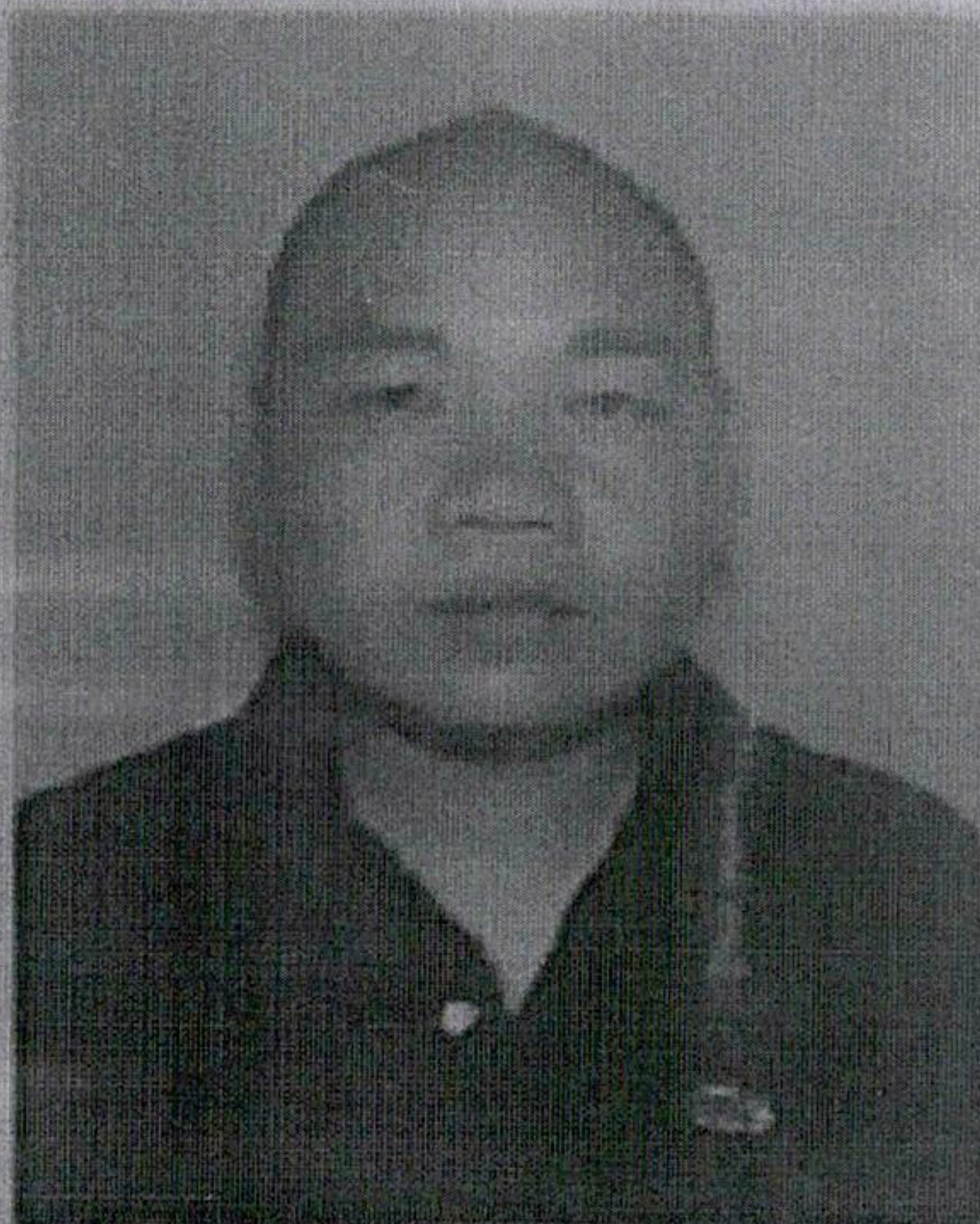

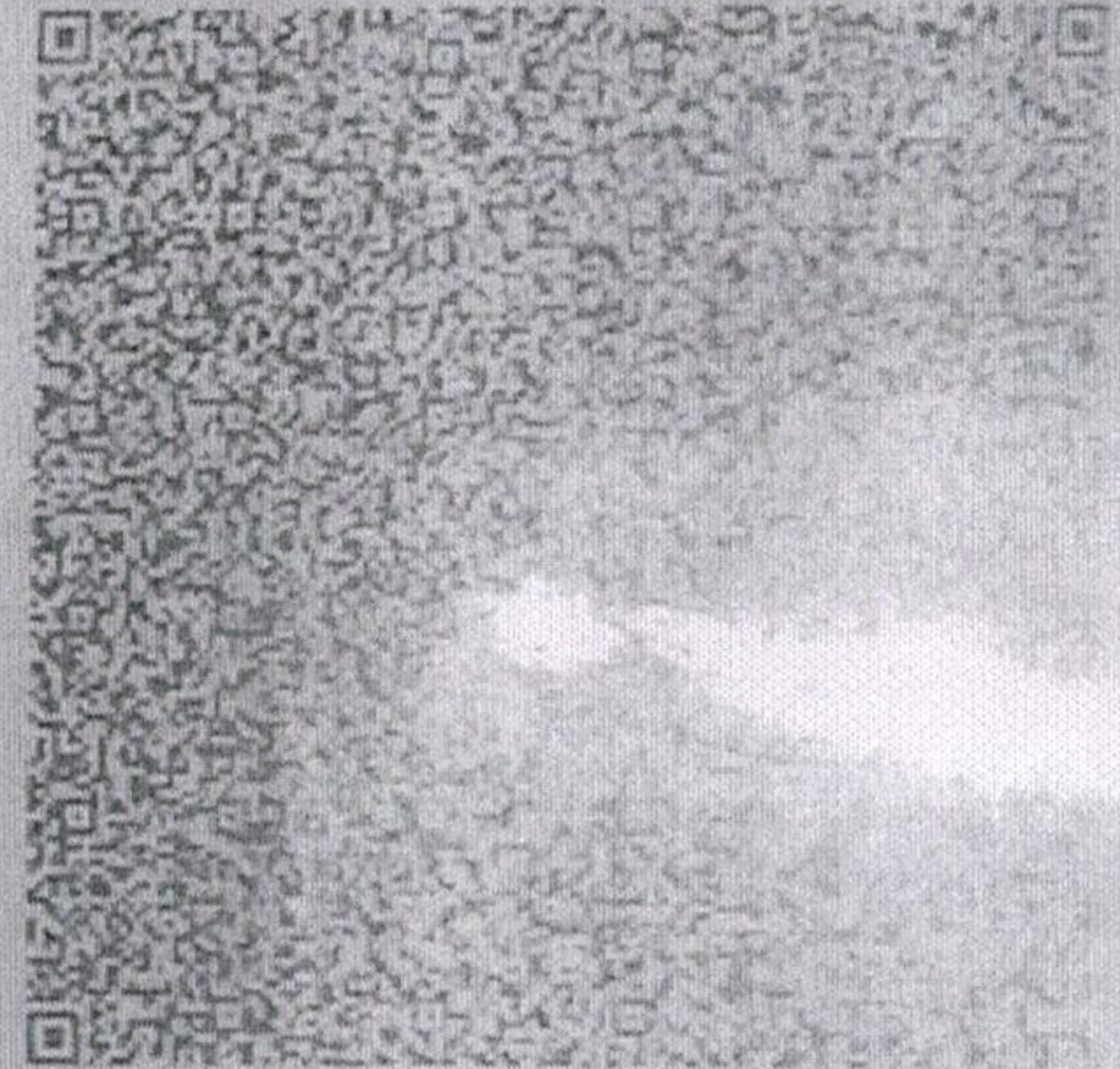
