### FIRST INFORMATION REPORT

1. OP Clean Sweep-III 25 June 2025. Based on inputs received from 3 CIB regarding the presence of war like stores(WLS) near the previously occupied KNA(B) camp, a joint search operation was launched by 21 AR(TOB Yangoubung) in coordination with 3 CIB and Molcham police station under Phase-III of OP CLEAN SWEEP on 25 June 2025 at around 1500 hr. Joint team conducted a deliberate search through dense jungle terrain and under inclement weather condition in general area TS Laijang( RM-751078). Detection efforts were spearheaded by the combine use of ED dog. DSMD operator and field search teams from 21 Assam rifles and Molcham Police rep. At around 1600 hr. DSMD operator successfully detected two and two improvised Explosive Device (IEDs) concealed under thick foliage, which were subsequently confirmed by ED dogs. Over the next 50 minutes at around 1650 hr, additional six IEDs were located at four different locations in the vicinity of 150 meters through the coordinated efforts of ED dog and the DSMD operator. This brought the total of **Eight Improvised Explosive Device (IEDs)** detected in the general area and the same were destroyed in situ by the team of 21 AR and Molcham Police. Total IEDs destroyed were **eight (08)**.

2. The team of Bravo company, 21<sup>st</sup> Assam Rifles brought remnants of the war-like stores and handed over to Molcham Police station on 25 June 2025 at 1500 hr. The handing over got delayed due to incessant rain in general area Yangoubung.
