Sir,

With due regards, I beg to state that today i.e. 21/06/2025 at about 04:00 a.m. received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at foothill of Gwarok Mahadev for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police and a troop of G/152 Bn. BSF Adhoc M&C XVI Bn. BSF led by Y. Sunanta, MPS, DSP(HQ)/TBL and Inspt. K. Nitaranjan Singh, OC/CDO-TBL under the command of Shri. N. Suraj Singh, Addl. SP(L&O)/TBL and under the overall supervision of Shri Shivanand Surve, SP/TBL have rushed to the spot immediately and launched a massive operation at 5:30 a.m. On searching and found the undernoted articles i.e. (1) 1 (one) SLR along with magazine, (2) 1 (one) SMG Carbine with magazine bearing Regd. No. NN9603 SAF 1972, (3), 1 (one) 9 mm Pistol with magazine, (4) 3 (three) Nos. of 36 HE Hand Grenade, (5) 20 (twenty) Nos. of .303 live rounds, (6) 10 (ten) Nos. of 5.56X45 mm. live rounds, (7) 10 (ten) Nos. of 5.56X30 mm. live rounds, (8) 10 (ten) Nos. of 9 mm live rounds, (9) 3 (three) Nos. of 7.62 mm (SLR) live rounds, (10) 3 (three) Nos. of detonators, (11) 1 (one) No. of Arming ring, (12) 2 (two) Nos. of tube launching, (13) 2 (two) Nos. of Helmet, (14) 17 (seventeen) Nos. of 7.62X39 mm. empty case, (15) 4 (four) Nos. of .303 live blank cartridge, (16) 8 (eight) Nos. of .303 empty case, (17) 1 (one) No. of WP Green 80 MK grenade, (18) 3 (three) Nos. of anti riot rubber bullet, (19) 3 (three) Nos. of Wireless Hand set from the spot at 04:55 a.m. Hence the above noted articles were seized at 05:56 a.m. by observing formalities. The massive searched Operation was conducted from 04:30 a.m. to 6:00 a.m. on the same day.

It may be mentioned that all the necessary formalities under BNSS i.e. preparation of seizure memo by taking videography during seizure could not be done at the spot as information was received from intelligence sources that some unknown miscreants may attack or some organised public mob may be initiated to forcefully and snatch the recovered arms ammunitions.

So, it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
