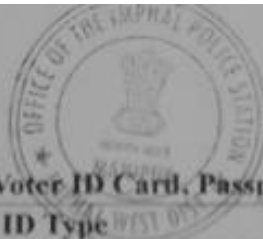

Sir,



I have the honour to report that today i.e, 31/05/2025 at about 5:30 am, while I was at the CDO Complex, Imphal West District, one of my source men came and informed me that, three persons in one Mahindra Thar(grey) B/Regn No. AR01L/ 2384 will be transporting huge consignment of Heroine powder concealed inside the said Mahindra Thar from Chandel to Senapati and the said vehicle will be arriving soon at Imphal Telegraph Office along NH-102. Accordingly, I recorded the statement of the source men and reduced in writing and a similar copy of the source report also has submitted to SP-IW through OC, CDO -IW for necessary action. Then, I along with my police team under the command of Inspt. Gunachandra Chanam, OC-CDO, IW and under the supervision of Shri. Gaurav Dogra, IPS i/c Addl.SP (Ops) and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and remained there watching for the said Mahindra Thar. At about 6:30 am, the said Mahindra Thar was seen coming towards our team and stopped the said vehicle at Imphal Telegraph office along NH-102. Three persons who were inside the said Mahindra Thar were detained there for verification. On verification they identified themselves as (i) Wangpem Lamkang (20) yrs s/o Shetphung Lamkang of Lamkang Khunjai, Chandel district, (ii) Jacop Shangkhil (18) yrs s/o Bening Shangkhil of Japhou, chandel District and (iii) Wanghon Khular (18) yrs s/o Ramshei Khular of Leipuntampak, Chandel District. Thereafter, I disclosed them about my identity and informed that I have discrete information that they are carrying (Narcotics drugs) Heroin powder concealed inside the said Mahindra Thar. On questioning, the detainee no.1 at the spot, he disclosed that the said Mahindra Thar was handed to him at Saivom, Tengenopal District by one Momo of Lamkang Khunou with 100 nos. of soap case containing Heroine powder concealed inside the roof of the said Mahindra Thar for delivering to one unknown person at Senapati. On questioning of detainee no. 2 & 3, they disclosed that they went along with detainee no.1 went to Saivom, Tengenopal District to receive the said Mahindra Thar containing 100 nos. of soap case containing heroine powder kept concealed inside the roof top of the said Thar to deliver to Senapati. I have informed OC, CDO IW to inform one Gazetted Officer to be present during searched and seizure of the said Mahindar Thar. Further, I have informed and prepared a requisition for the Mobile Forensic unit, Imphal West to be present and assisting in checking and seizing the Narcotic drugs Heroin powder. In the meantime, I also requested two unknown civilians near the spot to be independent witnesses for search and seizure on which they readily agreed. After sometimes, Shri N.Ingocha Singh, MPS, SDPO-Imphal arrived at the spot to be witness in the search and seizure procedure. Accordingly, when the Mobile Forensic team arrived, our team along with Shri. N.Ingocha Singh, MPS, SDPO-Imphal with the assistance of Mobile Forensic team Imphal West searched the roof top of the said Mahindra Thar by opening the roof from the front side in presence of the witnesses.. While checking, 100 (one hundred) nos. of soap case suspected to be containing Narcotic drugs (Heroin powder) were found inside the roof top of the said Mahindra Thar. Accordingly marked the 100 nos. of the said soap cases as S1 to S100 in presence of the witnesses for identification.



The 100(one hundred) nos. of soap cases were all homogenous in nature. After marking, the soap cases were opened one by one with the help of the Mobile Forensic Unit in the presence of witnesses and Shri. N.Ingocha Singh, MPS, SDPO-Imphal and found to be containing suspected Heroin powder in transparent plastic bags. The Mobile Forensic team took out a small amount of suspected Heroin powder from 100 nos. of soap cases with an interval of 5 and tested with their testing kits and on testing it gives positive result for Heroin powder. Each of the plastic bags were marked again as S1 to S100 and weighed by using electronic weighing machine in presence of two independent witnesses, Shri. The detected 100 (one hundred) numbers of soap cases containing Heroin powder were kept inside one cartoon box and packed and sealed using Facsimile of OC Imphal PS and marked as "S" and seized the same from the above three accused persons by observing formalities at 12:55 pm. Further seized i) one Redmi 10-Prime having IMEI Nos. 869525054853946 inserted with airtel sim card bearing mobile no. 7628010532(as disclosed by him), ii) one Infinix Note 50X having IMEI Nos. 357240541136934 & 357240548604728 inserted with hio sim card bearing mobile no. 9863323072(as disclosed by him), iii) One Aadhar Card bearing no. 3448 8684 3506 and iv) One Mahindra That (grey) B/Regn No. AR 01L/ 2384 on production by Wangpem Lamkang (20) yrs s/o Shetphung Lamkang of Lamkang Khunjai, Chandel district by observing formalities at 1. 00 pm. Also seized one itel mobile handset having IMEI No. 353561491524462 & 353561491524470 inserted with airtel sim card bearing mobile no. 7085704291(as disclosed by him) on production by Wanghon Khular (18) yrs s/o Ramshei Khular of Leipuntampak , Chandel District by observing formalities at 1:05 pm. Thus, the accused namely (i) Wangpem Lamkang (20) yrs s/o Shetphung Lamkang of Lamkang Khunjai, Chandel district, (ii) Jacop Shangkhil (18) yrs s/o Bening Shangkhil of Japhou, chandel District and (iii) Wanghon Khular (18) yrs s/o Ramshei Khular of

Leipuntampak, Chandel District were arrested from the spot at 1:15 pm, 1:20 pm & 1:25 pm respectively of the same day by observing formalities.

The arrested persons and the seized items are handed over to you for taking up further necessary legal action against them.
