Sir,

As per endorsement, I have made an Inquiry in c/w a report lodged by one Sinam James Singh, secretary Public Grievance, KSA. During the inquiry, the individual namely Kongkham Pradeepkuamar Singh aged about 36 yrs s/o K. Muhindro Singh of Thoubal Athokpam Khunou was found detained at KSA Office located at Thangmeiband. He was brought at the PS for proper examination and verification.

During the examination, the said Pradeepkumar is a police constable in Manipur Police Department and now posted at Imphal Police Station. He is a long absentee. He stated that he had issued fake appointment letters for various post of RIMS, Lamphelpat to nearly 10 job seekers and had collected a sum of approximately 80 lakhs from them. He further stated that he also issued fake appointment letters for various post of Manipur University to nearly 7 job seekers and also collected a sum of approximately 8 lakhs from them. He is a computer graduate and made fake appointment letters and other related documents by himself. Not only this he had collected many four wheelers from innocent individuals in the name of exchange of new car but till date not returned or given any car. He also made fake Notification of Manipur Police Housing Corporation Limited taking responsibility of himself by the Superintendent of Police, Imphal East to convince the innocent persons who want to exchange their old vehicle with new one. In due course of the inquiry, one victim of Pradeepkumar namely Khangchrakpam Herojit aged about 27 yrs s/o Kh. Shanta Singh of Iram Siphai Mamang Leikai appear at the PS and submitted a written report to OC/IPS regarding issuing of fake appointment for the post of LDC clerk of RIMS, Lamphelpat. Also another victim of Pradeepkumar namely Thokchom Sonia aged about 30 yrs w/o Athokpam Meghachandra Singh of Kongba Kshetri Leikai appear at the PS and submitted a written report by her husband to OC/IPS regarding the issuing of fake appointment letter for the post of LDC of Manipur University.

As, the offences committed by Kongkham Pradeepkumar Singh amounts to criminal breach of trust being a capacity of being a police and collected many vehicles from many innocent individuals, making fake appointment letters for purpose of cheating to many innocent job seekers by using forged documents and counterfeit seal.

It, is therefore requested to kindly register a regular FIR against the said Kongkham Pradeepkumar Singh for thorough investigation at the earliest.
