Sir,

I have the honor to submit herewith the enquiry report of the above-mentioned UD case for your kind perusal and further necessary action.

That on 13/06/2025 at @ 12.30 AM, the complainant namely Lanu Sinnu Aimol lodged a written report to OC/IPS, stating that on 12/06/2025 at around 8 pm, she came to know from one of her relatives that her son has passed away soon after knowing the information, along with her family and well-wishers went to the Adimjati Boys Hostel and they already took her son to the nearby hospital i.e. City Hospital. The circumstances surrounding his death are unclear and raise suspicion, particularly where all four of them were spending time with her son alone inside the pond. Also given the time lapse between the incident and the information received. She has strong reason to believe that there may be foul play or negligence involved, and she urge the authorities to conduct a thorough investigation. Hence the case and it refers to **UD Case No. 15/IPS/2025 dated 13/06/2025 U/s 194 BNSS.**

During the course of enquiry, the complainant was examined very carefully and minutely where she fully corroborated with the O.E lodged by her. The deceased person was identified as T. Molianboy (18 yrs) S/O T. Modan of Langol Village, Tengnoupal District. The place of occurrence was inspected very carefully and minutely along with the expert team of mobile Forensic Unit, FSL. Inquest was conducted over the dead body. During further course of investigation, post mortem examination of the dead body was conducted in presence of an Executive Magistrate with video coverage at RIMS Morgue. The Post Mortem report was collected from RIMS Hospital where the concerned MO opined that the death was due to asphyxia resulting from drowning. But, there are also some external injuries observed in the Post Mortem report (Bruise mark over the right parietal region of the head, 5cmX4cm, 3 cm from midline, 167 cm above heel, red). So, it is highly suspected that the deceased could have been murder by some unknown person for some unknown reason. On examination of some PW's, they are also giving some contradictory statements regarding the dead of late T. Molianboy (18 yrs). As such, it is considered converting the instant UD case into a regular FIR for further investigation.

It, is therefore submitted this report for your kind perusal and further necessary action to convert the UD case into a regular FIR.
