Subject: - Report.

Sir,

I have the honour to state that today i.e. 24/06/2025 at about 12:45 pm, a reliable information was received regarding the presence of some active cadres of UNLF organization in and around Babupara area with a view to commit prejudicial activities like extortion of money from government offices and general public etc. Based on the information, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW assisted by Inspector Anilchandra Mutum of CDO-IW and myself under the command of Shri Gaurav Dogra, IPS, i/c Addl. SP(Ops.) IW and under the supervision of Shri Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Babupara area. During that one suspected person along with one TVS NTORQ scooter red and black in colour bearing registration number MN06SH 2261 was detained at the office complex of SSA, Babupara. During spot verification, the detainee identified himself as Konthoujam Opendro Singh (46 yrs.) @ Ibomcha s/o K. Ibobi Singh of Mongsangei Awang Leikai, Imphal West District.

During preliminary verification, he disclosed that he is an active member of UNLF(P) organization (a faction of UNLF organization) and joined the said organization in January, 2025 through one s/s Commander Sunder (Ph. No. 9436818874) who is presently working as s/s Project Officer of Imphal East District of UNLF(P) organization and he (the detainee) is presently working under the command of the above mentioned s/s Commander Sunder and under the instruction of his commander Sunder, he was involved in extortion activities by serving threats to government offices located in and around Babupara area for getting contract works in the name of UNLF(P) organization. Further, he disclosed that he is also working with some active members/cadres of other underground groups namely (i) one Nongpoknganba (Ph. No. 7628003492) of UPPK organization (a faction of PREPAK organization), (ii) one s/s Project Officer Lemba of KYKL organization and (iii) one Naokhonba of UNLF(P) organization.

Hence, he was arrested from the spot i.e., at the office complex of SSA, Babupara at 02:00 pm by observing necessary formalities.

From his possession: (i) one POCO C65 mobile handset along with one Airtel SIM card bearing mobile no. 8730055563 (as disclosed by him), (ii) one HMD keypad mobile handset Model TA-1633 along with one Airtel SIM card bearing mobile no. 7629012590 (as disclosed by him), (iii) one black side bag containing one brown wallet with a sum of Rs. 3,800/- (rupees three thousand and eight hundred only) and one Aadhaar card bearing no. 5552 5955 6927 and (iv) one TVS NTORQ scooter red and black in colour bearing registration number MN06SH 2261 along with its key were seized at the spot at 02:07 pm by observing due formalities.

On thorough verification, he disclosed a person namely one Tomcha from Wangkhei who had contacted him for selling some illegal arms.

Immediately, as a part of follow up action based on his disclosure, the said CDO-IW team along with the arrestee rushed to Wangkhei area after giving prior information to Imphal East District Control Room and as pointed out by the arrestee, Tomcha was successfully detained from a blacksmith's workshop located at Wangkhei Tokpam Leikai, Imphal East District. On spot verification, the detained person identified himself as Tokpam Tomcha Singh (55 yrs.) s/o (L) T. Nilachandra Singh of Wangkhei Tokpam Leikai, Imphal East District (who later disclosed himself as the owner of the above-mentioned blacksmith's workshop).



During preliminary verification, he disclosed a person namely one Sarat from Soibam Leikai near Babina Diagnostic who came to his workshop in a motive to sell some fire arms which are in his possession. He further disclosed that Sarat ensured him to share an amount of Rs. 10,000/- after selling the arm to Konthoujam Opendro Singh (the arrestee).

Hence, he was arrested from the spot i.e., from his blacksmith's workshop located at Wangkhei Tokpam Leikai, Imphal East District at 04:13 pm by observing necessary formalities.

From his possession one Redmi 9 Prime mobile handset along with one Jio SIM card bearing mobile no. 6009152998 (as disclosed by him) was seized at the spot at 04:19 pm by observing due formalities.

Based on his disclosure, our team along with the arrestee namely Tokpam Tomcha Singh immediately rushed to the residence of Sarat located at Khurai Soibam Leikai, Imphal East District after giving prior information to Imphal East District Control Room and as pointed out by the arrestee, Sarat was successfully detained from his residence. On spot verification he identified himself as Keithellakpam Saratchandra Mangang (53 yrs.) s/o K. Mohon Mangang of Khurai Soibam Leikai Ahongei Leirak, Imphal East District.

As pointed out by him, one Redmi 8A mobile handset along with one Airtel SIM card bearing mobile no. 7085739248 (as disclosed by him), one Aadhaar card bearing card no. 4950 8638 3716 were recovered from a table in the store room of his house and one black plastic polythene bag containing: (i) one 9mm pistol bearing body no. 15065702 along with one magazine, (ii) one 9mm pistol bearing body no. 15336105 along with one magazine, (iii) eight nos. of 9mm ammunition and (iv) one .32 pistol marked with "AUTO MATIC PISTAL MADE IN U.S.A. AUTO PISTAL 7.65 7 ROUND" bearing body NO 7510 along with one magazine loaded with four rounds of 7.65mm ammunition, which was kept concealed under the table in the store room of his house was recovered at his instance.

Hence, he was arrested from the spot i.e., from his residence at 05:06 pm by observing necessary formalities and the above recovered articles were seized at his instance at the spot at 05:13 pm.

Hence, the arrested persons i.e., (i) Konthoujam Opendro Singh, (ii) Tokpam Tomcha Singh and (iii) Keithellakpam Saratchandra Mangang and the seized articles are handed over to you for taking further necessary legal action against them.


