Sir,

I have the honour to report that today i.e. the 27<sup>th</sup> June, 2025 at about 2:30 p.m. received a reliable information about the presence of some active members of the outfit KCP at Thangmeiband, Imphal West District. Based on the said information, teams of CDO/IE Unit along with woman police personnel conducted a searched operation at Thangmeiband Thingel Leikai, Imphal West District under the command of Inspt. N. Devadas Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS, Addl. SP(Ops)IE at 3:30 p.m. after providing prior information to Imphal West District Police.

In that, three unknown suspected person, two women and one man, were detained for spot verification at Thangmeiband Thingel Leikai, Imphal West. On verification, the detainees identified themselves as; (i) Aheibam Johnson Singh @ Khonthang (27 years) S/o (Late) A. Khogen Singh of Takyel Kolom Leikai, Lamphel PS, Imphal West, (ii) Ningthoujam Scolia Devi @ Chaoba (25 years) D/o N. Jadop Singh of Tairenpokpi Mayai Leikai, Lamshang PS, Imphal West District and (iii) Salam Binita Devi @ Bemma @ Tamna (22 years) D/o (Late) S. Yaima Singh of Ningthoukhong Mamang Leikai, Bishnupur PS, Bishnupur District.

On further verification, all the three detainees stated that they are active members of the outfit KCP (PWG) group. The first detainee, Aheibam Johnson Singh, stated that he joined the said outfit, KCP (PWG) group through one s/s - Captain Mr. Pari of KCP (PWG) in the month of September, 2024 and presently working under his command.

On further verification, of the second detainee, Ningthoujam Scolia Devi, stated that she joined the outfit, in the month of October, 2024 through one Mr. AK @ Pabungcha of KCP (PWG) group. The third detainee, Salam Binita Devi, stated that she joined the said outfit through one Sumati Devi of KCP (PWG) group in the month of March, 2024.

So, the detainees were arrested from the spot i.e. Thangmeiband Thingel Leikai, near Community Hall at 4:07 p.m. by observing due formalities. From the possession of the arrestee, Aheibam Johnson Singh, seized one mobile phone (Redmi 13 5G) bearing IMEI no. 868074076290242 & 868074076290259 along with one Airtel SIM card having no. 7630912678 and one wallet containing a sum of Rs. 120/- (one hundred twenty rupees) by observing due formalities at the spot i.e. Thangmeiband Thingel Leikai, near Community Hall at 4:15 p.m.

One mobile phone (Redmi A3X) bearing IMEI no. 866882075685606 & 866882075685614 along with one Jio SIM card having no. 9366534036 was seized from the possession of the arrestee Ningthoujam Scolia Devi by observing due formalities at spot i.e. Thangmeiband Thingel Leikai, near Community Hall at 4:20 p.m. From the possession of the arrestee, Salam Binita Devi, one mobile (Redmi 11) bearing IMEI no. 869271065069624/78 & 869271065069632/78 along with one Airtel SIM card having no 7630911875 was seized at the spot i.e. Thangmeiband Thingel Leikai, near Community Hall at 4:25 p.m. by observing due formalities.

Therefore, the arrested persons along with the seized items are being handed over to you for taking up further necessary legal procedures against them.


