

Subject: Submission of report.

Sir.

As endorsed, I have made a discreet inquiry in c/w G.D. Entry No. 13/IPS/2025 dated 20/06/2025. During the course of inquiry, the complainant namely Ripen Meinam (39) yrs S/o Meinam Ibomcha Singh of Lalambung Takhelambam Leikai, Imphal West, Manipur lodge a written report to the OC/IPS stating that on 19th June, 2025 at about 6.00 pm, while he was placing some clothes in the wardrobe located in his living room, he found that several ornaments belonging to his wife were missing. The stolen items included one gold necklace, two gold bangles and one gold earring. Upon inspecting the premises, he found that the unknown miscreant(s) might have climbed through the adjacent house and gained access to them through the western side window of their building located at Lalambung Makhong Takhelambam Leikai, RIMS Road, Imphal West District, Manipur. Upon checking his house, he found a foot print at the plastic storage bucket drum (Brite), kept near the window at the 2nd floor which he strongly suspect belongs to the intruder. The estimate value of the stolen gold jewellery is about Rs. 2,20,000/- (Rupees two lakh twenty thousand) approximately.

On further course of investigation, visited at the residence of the complainant at Lalambung Takhelambam Leikai, Imphal West and inspected the spot carefully and examined the complaint and recorded his statement on a sheet of paper. It is found that a foot print at the plastic storage bucket drum (Brite), kept near the window at the 2<sup>nd</sup> floor and the finger print was also found on the top of the iron admiral which was kept near the window. It was strongly suspect belongs to the intruder. The prima facie evidence was made out in the presence case. So, considering the fact, a regular investigation is highly required.

It is therefore, the above report is being submitted for kind perusal and further

necessary legal action against the involved culprits.
