Subject: - Report.

Sir,

I have the honour to state that today i.e. 01/07/2025 at about 05:55 pm, a reliable information was received from our own source and further corroborated from the information input provided by 33 AR regarding the presence of some active cadres of ZUF organization in and around Kekrupat area under Imphal PS with a view to commit prejudicial activities like extortion of money from shops and general public etc. Based on the information, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri. P. Achouba Meetei, MPS, Dy.SP(CDO)IW and under the supervision of Shri. Gaurav Dogra, IPS, i/c Addl. SP(Ops.)IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Kekrupat area. During that one suspected person was detained near the gate of Kekrupat Static Guard. On spot verification, the detainee identified himself as Namgaklung Kamei (42 yrs.) @ November s/o Miusin Kamei of Chingkhonglong Village, Tamenglong District.

From his possession, (i) one 9mm Pistol along with one magazine loaded with ten rounds of 9mm ammunitions, (ii) one Redmi 12 5G mobile handset along one Airtel SIM card bearing mobile no. 8131976483 (as disclosed by him) and (iii) one brown wallet containing one Aadhaar card bearing card no. 8076 5249 5608 and one ID card bearing IC No. ZJ-005 were recovered.

During preliminary verification, Namgaklung Kamei disclosed that he is presently working as s/s Deputy Chief of Army of ZUF(J) organization (a faction of ZUF organization) since the year 2017 under the command of one s/s Chairman Jenchui Kamei of ZUF(J) organization. He further disclosed that he was involved in extortion activities by serving monetary demands/threats and collected money from the transport vehicles plying on Imphal-Jiribam National Highway (NH-37) and Imphal-Dimapur National Highway (NH-2) for raising their party fund.

Hence, he was arrested from the spot i.e., near the gate of Kekrupat Static Guard at 07:05 pm and the above recovered articles were seized from the spot at 07:13 pm by observing formalities.

Hence, the arrested person and the seized articles are handed over to you for taking further necessary legal action against him.
