Sir,

With due regards, I have the honor to report that today i.e 6th July, 2025, at around 07.30 PM, while I was conducting normal frisking and checking along with a team of Imphal Police Station including women police personnel of Reserve Line Imphal West in front of Nupilal Complex, I/W, two female passengers who were coming on an auto rickshaw were found drunk and detained for verification. Immediately, they were brought at Imphal Police Station assisted by women police personnel for further necessary formalities. On arrival at the police station, they identified themselves as Gaisuiliu Kamei, 24 years, D/o Gaime Kamei of Tamenglong Medical Gate, Tamenglong District, Manipur, A/P North AOC and Irom Echan Devi (26) years, W/o Irom Royel Singh of Langthabal Mantrikhong Mayal Leikal, I/W District, Manipur. On further examination, it was also highly suspected that they were also under the influence of drugs. When examined minutely, they revealed that they are drug users and it was suspected that they may possess and concealed some drugs on their bodies. So, immediately the matter was informed to N. Ingocha Singh, MPS, SDPO-Imphal and he also arrived at the Imphal-PS. Accordingly they were informed about the search option of their bodies and wearing apparels U/s 50 ND&PS Act in written and they also expressed their willingness to be searched in presence of the civil witnesses and gazetted officer. Accordingly, they were searched one after another by women police personnel in presence of the Gazatted Officer and independent witnesses, and while searching, found 6 (six) plastic vials containing suspected to be heroin No. 4 from Irom Echan Devi and 1 (one) plastic vial containing suspected to be heroin No. 4 along with 4 (four) packets (red color) of lubricated condom marked as NIRODH from Gaisuiliu Kamei. On weighing all the recovered 7 nos. of plastic vials containing suspected to be heroin No. 4 by using a weighing machine, it weighs approximately 9(nine) grams and while weighing separately excluding the weight of the 7 plastic vials, the illegal drug suspected to be Heroine No. 4 in a transparent plastic pouch, it weighs approx. 1gm. So, the recovered items suspected to be Heroine No. 4 were marked as "A1", "A2", "A3", "A4", "A5" "A6" and "B1" seized from the possessions of Irom Echan Devi and Gaisuiliu Kamei along with 4 (four) packets (red color) of lubricated condoms marked as NIRODH at 08:30 PM and 08:40 PM respectively in presence of independent witnesses by observing due formalities. Further, the seized items were properly packed and sealed marked as "C" in presence of witnesses. Hence, Irom Echan Devi and Gaisuiliu Kamei were arrested at 08:45 PM and 08:50 PM respectively by observing formalities.

It is therefore submitted this report along with the seized articles and arrested persons for further necessary action.


