I am the honour to report that today i.e., 15/07/2025 at around 03:00 pm, received a reliable information from source that some persons are indulging in forging documents like vehicle registration card, Adhaar etc. using fake documents and selling/buying vehicles with fake registration numbers etc. in and around DTO-Imphal West District Office Complex Imphal since March, 2025. Immediately, self and police teams including 1 (one) team of DTO/IW conducted patrol and search of suspected persons along NH-102, stretch from Lilong Chajing to Singjamei Yumnam Leikai during which one suspected vehicle drove towards Imphal and intercepted him at Singjamei Yumnam Leikai. He was detained for verification. He identified himself as Md. Nawaj Khan (25) yrs, S/o Md Maneruddin of Kshetri Bengoon Yangbi, Imphal East District, Manipur, A/P Lilong Chingkhram Dam Makha, Thoubal District, Manipur. On physical checking the following items are found i.e., 1) One Alto car White in colour, bearing Regn. No. MN06L-3691, 2) One Registration Card of the Maruti Alto LXI, White in colour, bearing Regn. No. MN06L-3691 having Chassis No. 419519 and Engine No. 407283, 3) Adhaar one xerox copy standing in the name of Thoudam Heramani Singh, bearing No. 5047 1223 9059, 4) One Samsung Galaxy A15, Mobile Phone No. 9378076634, 5) Driving Licence in the name of Md. Nawaj Khan and 6) Sale Deed having 4 pages. On his disclosure another Maruti Alto STD, W. Red in colour with fake RC Book bearing Regn. No. MN06L-9010, having Chassis No. F8DN3047193 and Chassis No. MA3EYD81S00283596 which was found abandoned at the place near Awang khunou was also recovered. The said vehicle was bought to Imphal PS as local people gathered and started to create mob. He was arrested on the same day at 07:00 pm and the following items are seized by observing formalities today i.e 15/07/2025 at 7:30 pm

- 1) One Alto car White in colour, bearing Regn. No. MN06L-3691,
- 2) One Registration Card of the Maruti Alto LXI, White in colour, bearing Regn. No. MN06L-3691 having Chassis No. 419519 and Engine No. 407283,
- 3) Adhaar one xerox copy standing in the name of Thoudam Heramani Singh, bearing No. 5047 1223 9059,
- 4) One Samsung Galaxy A15, Mobile Phone No. 9378076634,
- 5) Driving Licence in the name of Md. Nawaj Khan and
- 6) Sale Deed having 4 pages.
- 7) One Alto Car, Red in colour, Regn No. MN06L-9010 along with Key.
- 8) One Registration Card bearing No. MN06L9010 having Chassis No. F8DN3047193 and Chassis No. MA3EYD81S00283596 owned by Thokchom Ranjita Devi.

The arrested person admitted that he is involved forging documents, used the same as genuine and obtained fake RC books /card and sell /received stolen vehicles.

The arrested person along with seized items are handed over to you for taking necessary legal action.
