Subject : Report regarding theft of gold ring from my shop.

Sir,

I have the honour to state that I am presently working as a salesman at a jewellery shop under the banner, "Princess Jewellers" located at Wahengbam Leikai, Imphal West District, Manipur.

That today i.e. 16th July, 2025 at about 03.00 pm, an unknown women came to our shop and claiming to purchase a gold ring and a gold neck chain. She asked me to show all the tray of gold rings to select one. Accordingly, I displayed all the available gold rings on the tray for her to choose from.

While checking each ring to find her size and preferred design, she finally selected one ring and asked me to calculate its price. As I was busy in calculating the price of the selected ring, she cleverly managed to hide another gold ring in her left hand and discreetly put it inside her bag. After I informed her that the price of the selected ring was Rs. 21,163/-, she asked me my Gpay number of the shop, claiming she would ask her friend to make the payment. I instead instructed her to click a photo of the Gpay QR code displayed at the shop and send it to her friend. She then clicked a photo of the Gpay QR code and left the shop without saying anything further. Due to her suspicious behaviour, I recounted the rings on the tray and found that one ring was missing. The stolen ring weight about 1 san and 5 chanings valued about Rs. 40,000/- (Rupees forty thousand) approximately.

It is, therefore, requested kindly to recover the stolen gold jewellery and take up necessary legal action against the unknown woman according to law.
