Subject: - Compliant regarding misuse of Vehicle Regd. certificate.

Sir,

With due respect, I, Suresh Gatani, a resident of Thangmeiband Yumnam Leikai, Imphal West District, would like to submit the following for your kind consideration and necessary action. That someone has misused the Registration Certificate (RC) of my vehicle a Maruti Suzuki Eeco Van bearing Registration Number MN01AG-5037, Engine No. G12BN692494, and Chassis No. MA3ERLF1500711318.

On 15th May, 2025, at about 11:30 AM, I visited the District Transport Office (DTO), Imphal West located at Babupara and submitted a written complaint regarding this matter. During my visit, I was shocked to learn from the records available at the DTO that a duplicate Registration Certificate had been issued for the same vehicle in the name of another person, falsely recording them as the second owner. However, I have never sold or transferred ownership of the said vehicle to anyone and I remain the first and only legitimate owner. Furthermore, I was informed at the DTO that two traffic challans had been issued against the said Registration Number MN01AG-5037, although I have not committed any such violations. This leads me to believe that the forged RC has been misused by another individual, resulting in these offences.

In light of the above, I earnestly request your good office to kindly take up the matter and initiate legal action against the person(s) involved in forging and misusing the duplicate RC. I further request that the fake Registration Certificate be seized, and that I be absolved of any responsibility for the challans or any offence committed through misuse of the forged RC.

Your kind attention and necessary intervention in this regard will be highly appreciated.
