**12. First Information contents:**

Today i.e. 04/07/2025 at 08.45 pm received a reliable information that on the same day at around 08.10 pm, one Bajaj V-15 motorcycle, ocean blue in colour, bearing registration no. MN04D-9880, plying from Khongjom Bazar side towards Sora side, ridden by an unknown rider dashed on the rear side of a stationary Tata Tipper, white in colour, bearing registration no. WB41H-6430, driven by an unknown driver, which was parked in a dangerous position facing towards south at Langthabal Loushi Khongjao near the culvert, along NH No. 102. As a result of which the unknown rider of Bajaj V-15 motorcycle sustained serious injuries on his person and evacuated to JIVAN Hospital, Kakching, for medical treatment. During that time another vehicle, Honda Activa, Blue in colour, bearing registration no. MN06SD-7484 plying from Khongjom Bazar side toward Sora side ridden by one unknown rider also dashed on the rear side of the aforesaid Tata tipper, which was parked at the same location. As such the unknown rider of the Honda Activa sustained serious injuries on his person and succumbed at the spot due to his injuries. The vehicles, Bajaj V-15 motorcycle, ocean blue in colour, bearing registration no. MN04D-9880 was partly damage and the Honda Activa, Blue in colour bearing registration no. MN06SD-7484 was badly damaged.

Hence a regular suo-motu case under **FIR No. 29(07)2025 KJM PS U/S 281/125(b)/324(4)/106(1) BNS 2023 and 122 MV Act.** has been registered for investigation.
