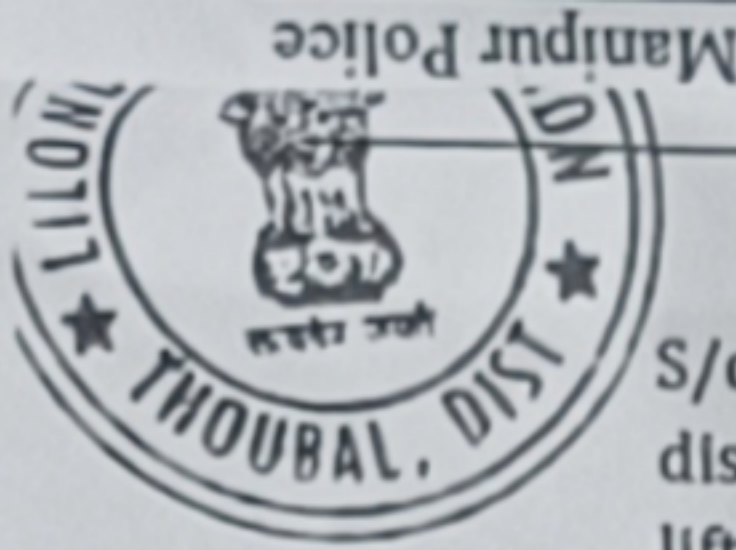

I have the honour to report that today i.e. 24/06/2024 at about 06:00 p.m. a reliable input was received regarding BM Aziz Hashmir of Lilong Hangamthabi a gang of vehicle lifter along with stolen vehicles was staying at his house. Acting on the information, a joint team of Commando Unit Thoubal led by Inspt. K. Nitaranjan Singh, Officer-in-Charge, Commando Unit, Thoubal and Inspt. N. Subash Singh, Officer-in-Charge, Lilong Police Station under the supervision of Shri. Hijam Devendra Singh, MPS, Addl. Superintendent of Police (Ops) Thoubal and under the overall supervision of Shri Shivanand Surve, IPS, Superintendent of Police Thoubal District immediately rushed to his house, before reaching his house 1 (one) suspected person was seen coming in Honda Active blue in colour without Regd. No. was intercepted on 24/06/2025 at 06:20 p.m. along IVR of Lilong Hangamthabi. On suspicion, the unknown person was detained for verification.



On preliminary verification, the unknown person identified himself as BM. Aziz Hashmir 21 yrs. S/o. (Late) Md. Liyaquat Ali of Lilong Hangamthabi, Thoubal District. On further verification he disclosed that he and his associates Aman of Lilong Loutara and Achouba of Lilong Dam Makha had lifted 2 (two) Royal Enfield Hunter 350 i.e. 1 (one) grey in colour from Sagolband and 1 (one) blue in colour from Thangmelband. Further he disclosed that the above Honda Activa was stolen from Lilong Bazar since 2/3 month back. Hence, he was arrested at 06:55 p.m. of 24/06/2025 from Lilong Hangamthabi IVR near his house and seized the above mentioned Honda Active blue in colour bearing Regd. No.-Nil, Chassis No.-ME4JF914CMG442398, Engine No.- JF91EG1441422, and 1 (one) Key on 24/06/2025 at 07:00 pm by observing formalities.

It may be mentioned that all the necessary formalities under BNSS i.e. preparation of seizure memo and arrest memo by taking videography during seizure could not be done at the spot as information was received from intelligence sources that some crowd may organised public mob to forcefully free the arrested accused person.


