With due respect I have the honour to lay the following few lines for your kind necessary action in view of the subject cited above.

That on 17-06-2025 the local daily news "Huiyen Lanpao" only had intentionally published basing on an information alleged to be given by KCP Finance and Department of Information and Publicity Tabungba Meitei some erroneous and harmful threatening to life which caused much prejudicial to the interest of the All Manipur Road Transport Drivers' and Motor Workers Union stating that:

Masi makha tana amuk hanna chatharaklabadi lupna pirakpa thoudang masa masana yajagadabani.

Attoppa wafam amana election toudana President, Secretary and Office bearersingna life time oiduna leibagi mami yamna chaona tari. Truck driversingdagi hanna louramba selphamdagi ngammi, yani haiduna hengatlaga nam-haduna louriba senphamsing haiba ngamjadaba driversingdadi mammittagi mapi tana houjik phaoba khangduna leiribani.

Mathakta piriba kayashing asi lup asigi Central Committee na yamna kupna khannaraba tungda Highway asidagi Union singna sel khaiba khudaktagi athingba thamle". Which is very much against the norms of the Union.

On account of such alleged threats causing and attempting to life and Curtailing of bounden duty of the Union have caused very much injury to the Union and hence, necessary legal action is highly call for at the earliest and punish the culprits according to law.

Early legal action in the matter will be highly appreciated.
