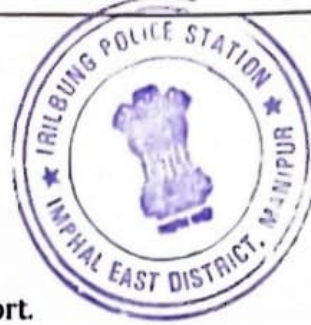

Sir,

As endorsed, I the undersigned have the honour to submit this enquiry report after completion. The report is as follows:-

The brief of the enquiry is that one Md. Amir Hussain (29 yrs) S/o Mr. Shahabuddin of Kiyamgei Mayai Leikai reported to OC-IBG/PS on 5th June, 2025 at 7:30 pm stating that he bought a G-Compass Vehicle from one Mr. Nafees Ahmad (35 yrs) S/o Munavvar Hasan of Chand Bagh, North-East Delhi on 25/04/2025 and completing all necessary formalities on the next day i.e, 26/04/2025 amounting Rs. 6,00000/- (Rupees six lakhs). He brought the said vehicle to his home at Kiyamgei Mayai Leikai, Imphal-East with a friend namely, Shakir (33 yrs) S/o Yusuf Ansari of Kairama, Shamli Uttar Pradesh-247774. Mr. Shakir is his close friend and visited his house 4/5 times earlier. That on 13th May, 2025 Mr. Shakir requested him (Md. Amir Hussain) for using the said G-compass vehicle for visiting Hatta, Imphal. However, the said Mr. Shakir didn't returned and when he (Md. Amir Hussain) called Shakir, it was found switch off. His wallet containing 6(six) ATM cards/ Credit card, documents like Aadhaar Card, Voter ID, Driving License, PAN card, RC book and other documents of the said G-Compass were inside the vehicle. Thereafter, he went to Kairana, Uttar Pradesh to trace Mr. Shakir as he is his good friend. However, he couldn't find Shakir. He delayed in reporting the matter as he went in searched of Mr. Shakir at Kairana, Uttar Pradesh. However, reported to take up necessary legal action against Mr. Shakir as per law.

Vehicle's details: G-Compass, Registration no. DL2CAX4421, Chassis no. MCAAJPCY1JFA02221, Engine no. 4002587, Model reg. dated 21/08/2017, colour:- Minimal Grey. Hence, a preliminary enquiry is conducted regarding the matter.

On enquiry examined the complainant Mr. Amir Hussain (29 yrs) S/o Mr. Shahabuddin of Kiyamgei Mayai Leikai who fully corroborated with the report made. He produced a photocopy of vehicle agreement deed for purchase of the vehicle. His father namely, Sahabuddin and his brother Md. Akbar were examined and they supported the fact that Mr. Shakir (the alleged accused person) came on 13th of May at around 6:30 am and took the said vehicle G-Compass from their residence.

The preliminary enquiry reveals that Mr. Shakir (accused) took the vehicle from the complainant and has failed to return it or respond indicating possible misappropriation or breach of trust. And the report made by the complainant is found genuine and requires further investigation under appropriate legal provisions.
