Sir,

I have the honour to report that today i.e. the 7th July, 2025 at about 2:00 p.m. received a reliable information from 33 AR corroborated with our own intelligence about the presence of some anti-social social elements at Bamon Kampu of Imphal East District. Based on the said information, teams of CDO/IE Unit under the command of Inspt. N. Devdas Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)IE rushed to the said area at about 2:40 p.m. and conducted mobile frisking and checking at Bamon Kampu Mayai Leikai.

In that, one suspicious unknown person was detained for spot verification and checking at Bamon Kampu Mayai Leikai, Imphal East District. On checking the detainee body, one mobile phone, a pair of iPods ear bud and one wallet were found and recovered from his possession. On verification, the detainee identified himself as one Thokchom Wilson Singh @ BK (26 years) S/o (Late) Th. Nandakumar Singh of Bamon Kampu Mayai Leikai, Irilbung PS, Imphal East District. On further verification, the detainee stated that he is an active member of the outfit PREPAK (Pro) joined through one Mr. Tenyson of PREPAK (Pro) in month of May, 2025 and presently working under the command of one Mr. Wanglen of PREPAK (Pro). The detainee further stated he had collected a huge amount of extortion money from various shops & stores located at Canchipur, Mantripukhri, Kakwa area for raising their party fund on the advice of the said Mr. Wanglen of PREPAK (Pro).

So, the detainee was arrested from the spot i.e. Bamon Kampu Mayai Leikai near Water Supply, Imphal-East District at 3:15 p.m. by observing due formalities. From his possession seized; (i) one mobile phone (Redmi 6 Pro) bearing IMEI no. 863309049961593 & 863309049961601 along with two SIM cards having no. Airtel 8798366468 and Jio - 9366539329 (ii) a pair of iPods ear bud and (iii) one wallet containing a sum of Rs. 20/- (twenty rupees) at the spot i.e. Bamon Kampu Mayai Leikai near Water Supply, Imphal-East District at 3:20 p.m. by observing due formalities.

Therefore, the arrested person along with the seized items is being handed over to you for taking up further necessary legal actions against him.
