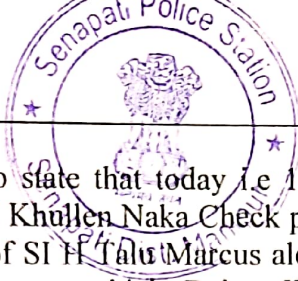

I have the honour to state that today i.e 18/08/2025 @ 3:00 pm, a random frisking and checking was conducted at T Khullen Naka Check point by SOT (Special Operation team) Senapati Police under the command of SI H Talu Marcus along with D-78 CRPF and B-109 CRPF (QAT). While frisking and checking, one vehicle Bolero White in colour bearing Reg. No. WB06P-8009 was seen coming from Imphal side towards Senapati. The said vehicle was stopped for frisking and checking. On enquiry, the driver of the vehicle is identified as Md. Sajid Khan (35) yrs s/o Md. Abdul Manap, Moijing Awang Leikai, PO & PS-Thoubal, Thoubal District, Manipur- 795138. On checking the vehicle, suspected WY tablets (Amphetamine) was found concealed under the Oil tank of the vehicle. Lunlenmoi Vaiphei (Executive Magistrate) was deputed for doing the necessary procedures.

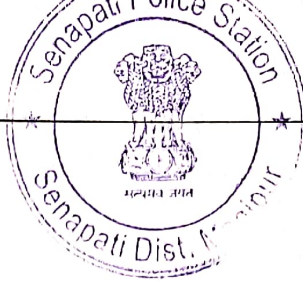
