

I have the honour to report that today i.e. the 20th February, 2025 at about 5:00 a.m. received an information from a reliable source about the concealment of a nos. of arms, ammunitions and explosives by unknown arms miscreants in general area of Bumpa Khullen Village, Kangpokpi District. Based on the said information, a combined team of CDO, Imphal East District and a column of 5/9 GR under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Kh. Herojit Singh, MPS Addl. SP(Ops) Imphal East District conducted a searched operation in the general area of Bumpa Khullen Village, Kangpokpi District at about 5:40 a.m.

During the search operation, there found the under-noted arms, ammunitions and explosives at the hilltop of Bumpa Khullen Village, Imphal East District.
