Today i.e. 14/06/2025 at 4:00 PM, based on a specific input from police local source, corroborated by 4 MAHAR (BORDERS) and FGT, Imphal that some unknown armed miscreants have concealed some arms, ammunitions, explosive etc. at Thayong Chingyang Shangran Ching Makha Laikot Kom village. A combined security team led by Ms Sophia Shintuidang MPS(P) OC/YPI-PS along with Yaingangpokpi police teams, one section of 4 MAHAR (BORDERS) under the command of Lt Col Vipin Dhillon, one section of B/69 Bn. BSF, one section of E/119 Bn. BSF and MR/IRB rushed to the spot and launched a massive operation at 4:00 PM and concluded at 06:15 PM on the same day. Today i.e. 14/06/2025 at 4:00 PM, based on a specific input from police local source, corroborated by 4 MAHAR (BORDERS) and FGT, Imphal that some unknown armed miscreants have concealed some arms, ammunitions, explosive etc. at Thayong Chingyang Shangran Ching Makha Laikot Kom village.
