Today i.e. the 12th July, 2025 at about 7.30 a.m. received a reliable information from 5/9 GR and corroborated with own intelligence about the presence of some active members of the outfit KYKL at general area of Laikhong,

Imphal East District. Based on the said information, my team and a column commander of 5/9 GR were stationed and conducted frisking and Checking near 200 mtrs South from the check post of 5/9 GR Laikhong at about 8:00 a.m.

In that, two suspicious unknown person came from Keithelmanbi side towards Laikhong and they were detained for spot verification and upon verification, the detainees were identified as one 1. **Shagolshem Lalit Meitei (36 years) S/o S. Tomba Meitei of Itham Mamang Leikai,, Imphal East District** and 2. **Ahongsangbam Tomba Singh(43 years) S/o A. Ibohal Singh of Itham Wangma Leikai.**

On further verification, the detainees stated that they were an active member of the banned outfit KYKL . **Ahongsangbam Tomba Singh S/o A. Ibohal Singh** further stated that he was recruited into KYKL through one Mr Maimu of KYKL in the year, 2009 and **Shagolshem Lalit Meitei (36 years) S/o S. Tomba Meitei** stated that he was recruited through **Late Laishram Nobin Singh of Tumukhong** in the year 2008.

So, the detainees were arrested from the spot i.e. Laikhong, 200 mtrs South of 5/9 GR Post, Laikhong, Imphal East District at 11.00 a.m by observing due formalities.

The arrested persons were brought to PS for further necessary action.

Hence, a suo moto case has been registered under FIR No 11(07)2025 TBL-DAM-PS U/S 20 UA(P) Act for investigation.






