Subject: Report.

I have the honour to state that today i.e. 16/05/2025 at about 03:20 am, a reliable information was received from our own source and further corroborated from the information input provided by 33 AR regarding the presence of some active cadres of KCP(PWG) organization (a faction of KCP organization) in and around Sawombung area of Imphal East District to commit prejudicial activities like extortion of money from the general public and shops etc. Based on the information, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri P. Achouba Meetei, Dy. SP(CDO)IW and under the supervision of Shri Gaurav Dogra, IPS, i/c Addl. SP(Ops.)/IW and under the overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted search operation at Yourabung area. During that one suspected person was detained for spot verification and checking at a house located at Yourabung Ward No. 2 School Leirak, Imphal East District. On spot verification, he identified himself as Lambalmayum Bobo Meetei (41 yrs.) @ Eshen @ Mani S/o L. Naba Meetei of Yourabung Ward No. 2 School Leirak, Imphal East District (who later disclosed himself as a resident of the said house).

During preliminary verification, he disclosed that he is an active member of KCP(PWG) organization (a faction of KCP organization) and joined the said organization in the year 2023 through one Bobo of KCP(PWG) organization from Pukhao area and he is presently working under the command of one s/s General Secretary Awangba of KCP(PWG) organization and under the instruction of the above mentioned s/s General Secretary Awangba, he was involved in extortion activities by serving monetary demands/threats and by collecting money from government offices/officials located in valley area and the extorted money were handed over to their commander i.e., s/s General Secretary Awangba as their party fund. Hence, he was arrested from the spot i.e., his residence located at Yourabung Ward No. 2 School Leirak, Imphal East District at 04:11 am by observing necessary formalities.

From his possession, (i) one OPPO 2A5 2020 mobile handset along with one Jio SIM card bearing mobile no. 9863169823 (as disclosed by him) and (ii) one Aadhaar card bearing no. 9123 5027 2934 were seized at the spot at 04:19 am by observing due formalities.

G After thorough verification, he disclosed that his associate namely one Chandra (who is presently staying at Sawombung Kabui Khunjao) of KCP(PWG) organization was also involved in committing the above mentioned extortion activities

Immediately, our team along with the arrestee rushed to Sawombung Kabui Khunjao area of Imphal East District after giving prior information to Imphal East District Police Control Room and conducted search operation at the said area. During that as pointed out by the arrestee, our team successfully detained his associate Chandra for verification and checking from a house owned by one Palmei Kumarjit Kabui S/o. P. Maipak Kabui located at Sawombung Kabui Khunjao, Imphal East District. During spot verification, he identified himself as Yumnam Chandra Meetei (40 yrs.) S/o Y. Mohon Singh of Yourbung Mamang Leikai, Imphal East District a/p Sawombung Kabui Khunjao, Imphal East District.

During preliminary verification, he disclosed that he is also an active member of KCP(PWG) organization (a faction of KCP organization) and joined the said organization in the year 2024 and he is presently working under the command of the above mentioned s/s General Secretary Awangba (Ph. No. 7085360263) of KCP(PWG) organization and under the instruction of the above mentioned s/s General Secretary Awangba, he along with the above mentioned arrestee was involved in extortion activities by serving monetary demands/threats and by collecting money from government offices/officials located in valley area and the extorted money were handed over to their commander i.e., s/s General Secretary Awangba as their party fund. Hence, he was arrested from the spot i.e., a house owned by one Palmei Kumarjit Kabui S/o. P. Maipak Kabui located at Sawombung Kabui Khunjao, Imphal East District at 10:14 am by observing necessary formalities.

From his possession, (i) one Redmi 12 5G mobile handset along with one Airtel SIM card bearing mobile no. 7085523811 (as disclosed by him) and (ii) a brown wallet containing: (a) a sum of Rs. 2,780/ (Rupees two thousand seven hundred and eighty only) and (b) one Aadhaar card bearing no. 6092 2568 2507 were seized at the spot at 10:22 am by observing due formalities.

Hence, the arrested persons and the seized articles are handed over to you for taking further necessary legal action against them.
