I have the honour to report that today i.e. the 20th May, 2025 at about 8:30 a.m. received a reliable information about the presence of one active member of the outlawed outfit KCP at Sawombung area of Imphal East District. Based on the said information, a combined team of CDO/IE and 5/9 GR under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri Y. Joyraj Singh, MPS Addl. SP(Ops)IE rushed to the said area and conducted a C.I. Ops. at 9:20 a.m.

In that, one suspicious unknown person was detained for spot verification at the eastern side of Sawombung Thong, Imphal East District. On verification, the detainee identified himself as one Phijam Tomba Meitei @ Meiraba (49 years) S/o (Late) Ph. Kokchao Meitei of Sekta Mayai Leikai, Lamlai PS, Imphal East District. On further verification, the detainee stated that he is an active member of the outfit KCP (Apunba) group joined through one Mr. Ratan of KCP (Apunba) in the month of July, 2023 and presently working under his command. The detainee further stated that recently, he had extorted money from an Oil Pump located at Lamlai bazar and one private school at Nungoi area of Imphal East District on the advice of the said Mr. Ratan of KCP (Apunba) for raising their party fund.

So, the detainee was arrested from the spot i.e. eastern side of Sawombung Thong, Imphal-East District at 10:00 a.m. by observing due formalities.

Thereafter, the arrested person is being handed over to you for taking up further necessary legal actions against him.
