I have the honour to report that today i.e. the 24th May, 2025 at about 4:30 p.m. received a reliable information from 10 Bn. BSF corroborated with our own intelligence, about the presence of one active member of the outlawed outfit KCP at Sawombung area of Imphal East District. Based on the said information, a combined team of CDO/IE and 10 Bn. BSF conducted C. I. Ops. at Sawombung Thongkhong, Imphal East District under the command of Shri. Y. Joyraj Singh, MPS, Addl. SP(Ops)IE at about 5:30 p.m.

In that, one suspicious unknown person was detained for spot verification and checking at the eastern side of Sawombung Bridge, Imphal East District. On checking his body one mobile phone was found and recovered. On verification, the detainee identified himself as one Moirangthem Hemba Singh @ Laiba (25 years) S/o M. Dhamen Singh of Pungdongbam Mayai Leikai, Imphal East District. On further verification, the detainee stated that he is an active cadre of the outfit KCP (Apunba) group joined through one Mr. Bijen @ Muthi of KCP (Apunba) in the month September, 2023 and got his basic military training for 15 days under the command of one s/s – Corporal Mr. Sanathoi of KCP (Apunba). He further stated that he is presently working under the command of one s/s – Sergeant Mr. Lamyamba @ Papa of KCP (Apunba) group.

So, the detainee was arrested from the spot i.e. from the eastern side of Sawombung Bridge at 6:02 p.m. and seized one mobile phone (Redmi) along with one Jio SIM card from his possession by observing due formalities at the spot i.e. eastern side of Sawombung Bridge at 6:05 p.m.

Thereafter, the arrested person along with the seized mobile phone is being handed over to you for taking up further necessary legal actions against him.

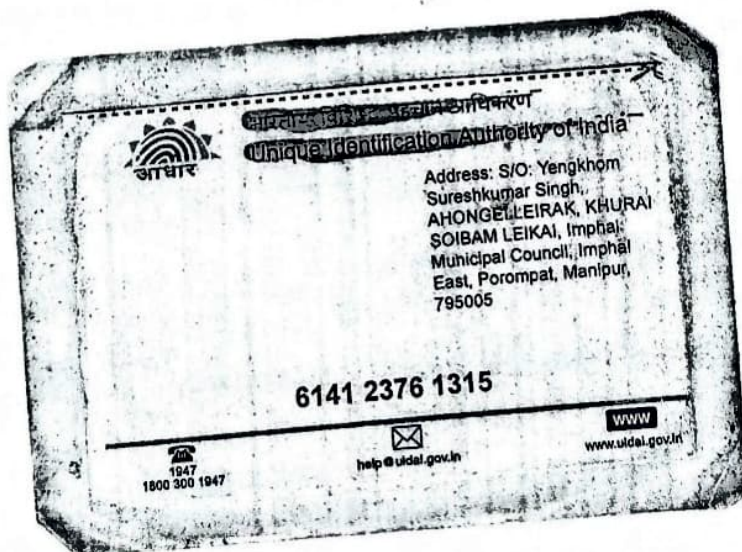
