Sir,

I have the honour to report yesterday i.e. the 6th June, 2025 at about 9:00 p.m. received an information from FGT (Field General Team) Imphal, BSF corroborated with our own intelligence about the presence of some active members of the outfit KCP at Sawombung Wari area of Imphal East District. Based on the said information a combined team of CDO/IE and 8 Bihar Regiment led by myself under the command of Inspt. N. Devdas Singh, OC-Commando Imphal East Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)Imphal-East rushed to the said area and conducted a searched operation at the said area at 10:00 p.m.

In that, one suspected person was detained for spot verification and checking at Sawombung Wairi, Imphal East District. On checking his body one mobile phone and one AADHAR card were found and recovered. On verification, the detainee identified himself as one **Wahengbam Naoton Meitei @ Ngachomi @ Chingshang (35 years) S/o (Late) W. Iboba Meitei of Phoubakchao near Water Supply, Imphal West. A/p - Sawombung Wairi, Imphal East**, an active member of the outlaw outfit KCP (PWG) militant group.

On further verification, the detainee stated that recently he had threatened the general public with grave consequences for allegedly defying arbitrary and unauthorised 'moral policing' directives. Further, it came to learnt that, invoking his association with the banned outfit, the detainee issued specific threats of harm to the individual in an attempt to in still fear and force compliance. Since, the act was intentional, unlawful, and carried out with complete disregard for the law and civil liberties.

For his serious criminal offence involving targeted intimidation, coercion, and an effort to unlawfully assert the will of a militant group over a private citizen. Further, such conduct poses a direct threat to public safety and constitutes a wilful attempt to undermine legal authority and democratic order, the detainee was arrested from the spot i.e. from Sawombung Wairi, Imphal East at 10:32 p.m. and seized; (i) *one mobile phone (Vivo Y28 5G) bearing IMEI no. 863587079116812 & 863587079116804 along with one Airtel SIM card bearing no. 7085135033 and (ii) one AADHAR Card* at the spot i.e. Sawombung Wairi at 10:35 p.m. by observing all formalities.

Therefore, the arrested person along with the seized mobile phone is being handed over to you for taking up further necessary legal procedures.
