Indian Penal Code, Sections 153A, 153B, 295A, 298, 504 & 505: Promoting enmity between Kuki community and different groups, prejudices on Kuki community, malicious acts on Kuki community and Statements as "Kuki refugees" conducive to public mischief thereby promoting hatred, disunity and sectarianism, parochialism, regional attitudes and communal feelings among various tribes and groups in the State.

ST/SC(Prevention of Atrocities) Act 1989, IPC 153A, 295A, 504 & the gazette of India extra ordinary 2161/43, Schedule iv(C paragraph 3(2), modification to the constitution(ST)(part C states) Order, 1951, Schedule Part II-Manipur: For tagging different Kuki tribes as Refugees such as : i) Thadou, ii) Paite, iii) Gangte, iv) Simte, v) Hmar, vi) Vaiphei, vii) Lushai-Mizo, viii) Sukte, ix) Ralte, x) Mate, xi) AKT xii) Zou etc in the so called indigenous MONOLITH erected at Sawombung Kabui Khunjao, Imphal against the Gazette of India 1951 & 1956 for Manipur.
