Sir,

I have the honour to report that today i.e. the 13<sup>th</sup> June, at about 5:00 a.m. received a specific and actionable intelligence regarding the suspected presence of an illegal communication setup at Baruni Hill, Imphal East District. Based on the said information, teams of CDO/IE Unit under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops) Imphal-East District and under the command of Inspt. N. Devdas Singh, Officer-in-Charge Commando Imphal East Unit rushed to the said area and conducted a searched operation at 6:30 a.m. at the Mandav (pavilion) of a temple located at Khalong, Baruni Hill, Imphal East District.

During the search, a concealed wireless communication assembly was discovered and recovered from the rooftop and surrounding premises of the structure. The setup was found to be a fully operational and self-sustaining wireless repeater system, consisting of transmission and receiving units, an antenna, and an independent power supply system comprising multiple solar panels, batteries, and an inverter. The system is capable of receiving, amplifying and re-transmitting VHF/UHF signal over long distances which is ideal for co-ordinating movements of arms miscreants over long distance, remote areas and difficult terrains. The use of off-grid power sources suggests a deliberate attempt to ensure uninterrupted and covert operation without dependence on conventional infrastructure and reliance on public network.

The CDO team dismantle/take off all the items and equipments which were being installed at the mandap and its surrounding premises. Details of the items which were recovered by the CDO team were as follows:


