I have the honour to report that today i.e. the 15th June, 2025 received a reliable information from our own source corroborated with the intelligence of 4 AR and 165 TA that an unlawful organization, KCP-MC Progressive, led by SS Finance Secretary Naoba @ Nongthang, about the extortion of a huge amount of money from the general public, Government Officials and also involved in kidnapping for extortion. Further, additional information was provided by Inspector Md. Rajib Khan, In-Charge Cyber Crime Unit/IE that the above-mentioned unlawful organization is loitering in an around Sawombung and Pundongbam area of Imphal-East District. Based on the said information, a combined team of CDO/IE, 4 AR and 165 TA launched a counter insurgency operation at Sawombung area of Imphal East District under the command of Inspt. N. Devdas Singh, Officer-in-Charge Commando Imphal-East Unit and under the supervision of Shri. Y. Joyraj Singh, MPS, Addl. SP (Ops) IE and under the overall guidance of Shir. Rakesh Balwal, IPS Sr. Superintendent of Police Imhpal East District at 2:00 p.m.
