

Sir,

I have the honour to report that today i.e. the 21st June, 2025 at about 4:00 a.m. received a credible information from our own intelligence about the concealment of a huge nos. of arms, ammunitions and explosives by unknown arms miscreants in general area of Phaknung village and its surrounding area of Imphal East District. Based on the said information, teams of CDO/IE assisted by SI. B. Debson Singh of CDO/IE Unit under the command of Inspt. N. Devdas Singh, Officer-in-Charge Commando Imphal East Unit under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops) Imphal-East District and Shri E. Roshan Singh, MPS, Dy. SP CDOIE rushed to the said area and conducted a searched operation at 5:00 a.m.
