I am to state that on 26/06/2025 at about 7:15 pm 3(three) teams of special CDO, unit Khabeisoi, i.e. ASI. K. Romen Singh and Hav Gobin Singh including myself, led by Subedar L. Bebekananda Singh OC-SPL/CDO under the overall guidance of Dr. S. Ibomcha Singh, MPS, C.O. 6th IRB, In-Charge Special CDO unit, Khabeisoi conducted normal frisking and checking Lamlai Sawombung side. During the frisking and checking 1(one) unknown person was seen coming on foot on very suspicious manner towards Imphal to Sawombung side. Due to his suspicious nature he was detained for verification on the spot. On verification he identified himself as Mr. Nongmeikapam Jilish Meitei (29) s/o Nongmeikapam Babu Meitei of Samurou Awang leikai Imphal West Dist.

On spot questioning, he disclosed that, he is a cadre of KCP (PWG). He joined in the year 5th June, 2023 through one Mr. Lamyamba Khuman Chairman of KCP. Further, he disclosed that he was working under one S/S. Mr. Jackson of KCP (PWG) and collect the extortion money from private firm and general public for the welfare of banned organization KCP (PWG). He got 15(fifteen) days basic military training at Kameng Sabal, Imphal West District. He was arrested near Chingarel Tejpur Petroleum at 9:42 pm.

So, I therefore handing over to you the arrested person for taking up further necessary legal action against him.
