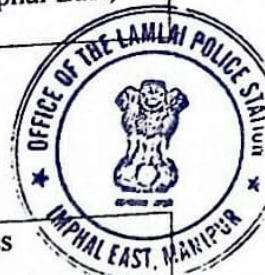

I have the honour to report that Today i.e. the 4th July, 2025 at about 4:00 a.m. received a credible information from our own source corroborated with the intelligence of M&N sector QAT & Range Imphal QAT, CRPF about the concealment of a huge nos. of arms, ammunitions and explosives by unknown arms miscreants in general area of Chingkhei Ching, Imphal East District. Based on the said information, a combined team of CDO/IE and M&N sector QAT & Range Imphal QAT, CRPF under the supervision of Shri. Ak. Sadananda Singh, MPS in charge Addl. SP (Ops) Imphal-East District and under the command of Inspt. N. Devdas Singh, Officer-in-Charge Commando Imphal East Unit rushed to the said area and conducted a searched operation at 4:30 a.m.

During the search operation, one jute bag and one plastic polythene bag, orange in colour were found hidden in the bushes at the Eastern side of Chingkhei Ching, under Lamlai Police Station, Imphal-East District. On opening the said jute bag and plastic polythene bag the undernoted arms, ammunition, explosives and others items were found containing inside the bags.

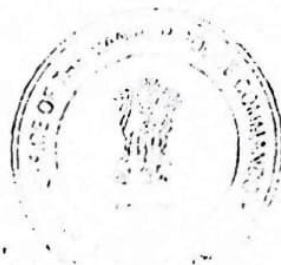
