Sir,

I am to state that today, i.e. 15/07/2025 at about 4:00 pm received an input from 33rd Assam Rifles about the movement of newly recruited UG's involved in carrying out unlawful activities at Yourabung Khunou area. On receiving the information, 2(two) teams of special CDO unit under the Command of Sub. L. Bebekananda Singh, OC-SPL/CDO Unit, Khabeisoi, including me under the supervision of Dr. S. Ibomcha Singh, MPS, C.O. 6th IRB &SP In-Charge Special CDO unit, Khabeisoi immediately rushed to the said area and conducted frisking and checking at Yourabung Khunou area. During the frisking and checking, 1(one) unknown person moving towards Imphal from Lamlai by foot on very suspicious manner and was detained for verification. On spot verification, he disclosed himself as Mongjam Ajoy Singh, aged about 35yrs @ Mongba S/O MongjamTomba Singh, aged about 62yrs from Lamlai Makha Leikai, Imphal East District.

On spot checking, 1(one) Mobile Phone Readmi 12 C light green in colour along with 1(one) airtel sim card bearing no. 8731930060 was found from his pocket. On further questioning, he disclosed that he is an active cadre of banned PREPAKgroup. He joined the group through one Mr. Roliya on November. 2024 and got 35(thirty five) days training under one Mr. Punsiba an active cadre of PREPAK held somewhere at Phayeng area, Imphal West District. Hence, he was arrested at 4:31 pm from the spot and seized the above articles at 4:36 pm by preparing legal formalities.

The arrested person and seized item are handed over to Lamlai Police Station for further necessary legal action.
