Today i.e. 16/07/2025 at about 2:10 pm received an information that on the same day at about 2:00 pm one Honda Activa, white in colour driven by unknown person which was coming from Napet Palli towards Sawombung side collided with one Tata Magic, White in colour bearing red. No. MN06SK K2101 coming from opposite direction at Phoulabi Bridge along NH-202 Imphal Ukhrul road due to rash and negligent driving/riding on the part of the driver/rider of both the vehicles. As a result of which the scooterist and the pillion rider of Honda Activa got injuries on their persons and evacuated to nearby hospital for medical treatment. Both the vehicles were also damaged.
