I have the honour to report that today i.e. the 27th July, 2025 at about 11:00 a.m. received a reliable information from our own source about the presence of some anti-social elements at Huidrom Village and its surrounding area of Imphal-East District. Based on the said information, teams of CDO/IE Unit under the command of Inspt. N. Devdas Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops) Imphal-East Unit rushed to the said area and conducted a random frisking and checking to the suspected passersby at 12:10 p.m.

In that, two suspicious persons coming in a scooter were detained for spot verification and checking at Kanglam Road Huidrom Village, near Waiting Shed Imphal East. On checking the driver of the scooter, one mobile phone and a sum of Rs. 700/- (seven hundred rupees) were found and recovered. On verification, the detainee identified himself as one **Phijam Joychandra Meitei @ Amuyaima (35 years) s/o Ph. Ibomcha Meitei of Sekta Mayai Leikai, Lamlai PS, Imphal East District**. On checking the pillion rider of the scooter, one wallet containing two nos. of ID cards and one Driving License were found and recovered. On verification of the pillion rider, he identified himself as one **Oinam Niranjit Singh (21 years) S/o O. Indrajit Singh of Lilong Chajing Mamang Leikai, Singjamei PS, Imphal West District**.

On further verification, the driver of the scooter (**Phijam Joychandra Meitei**) stated that he is an active member of the outfit KCP- Apunba (City Meitei) group joined through one Mr. Tomba of KCP- Apunba (City Meitei) group in the month of May, 2023 and got his basic military training for eleven days under the command of one Mr. Bobo of KCP- Apunba (City Meitei). The pillion rider (**Oinam Niranjit Singh**) stated that he joined the said outfit KCP - Apunba (City Meitei) group through one Mr. Ibungo of their outfit in the month of December, 2024.

Both the arrestees further stated that they are presently working under the command of one Mr. Paikhomba of KCP - Apunba (City Meitei) group and on the advice of the said Mr. Paikhomba today they came to collect extortion money from a Brick Field located at Huidrom Village, Imphal East.

So, both the detainees were arrested from the spot i.e. Kanglam Road Huidrom Village, near Waiting Shed Imphal East at 12:40 p.m. and seized; (i) one Scooter (*Vespa Piaggio*) yellow in colour, along with registration certificate, (ii) one mobile phone (*Redmi Note 10 PRO*) bearing IMEI No. 867217056934930/22 & 867217056934948/22 along with one Jio SIM card having no. 6009557118, and (iii) a sum of Rs. 700/- (seven hundred rupees) from the possession of the arrestee (**Phijam Joychandra Meitei**) at the spot i.e. Kanglam Road Huidrom Village, near Waiting Shed Imphal East by observing due formalities at 12:45 p.m. From the possession of the arrestee (**Oinam Niranjit Singh**) seized one wallet containing one AADHAR card, one PAN card and one Driving License were seized at the spot i.e. Kanglam Road Huidrom Village, near Waiting Shed Imphal East by observing due formalities at 12:50 p.m.

On further verification of both the arrestees, it came to learnt that one of their associates namely, **Soram Abungcha Meitei** was waiting for them at Kairang Maning Leikai, Imphal East. Immediately, our team along with the

arrestees rushed to the said area and on the pointing of the arrestee, arrested one active member of the outfit KCP - Apunba (City Meitei) group namely **Soram Abungcha Meitei (39 years) S/o S. Babu Meitei of Pourabi Makha Leikai, Imphal East** from the spot i.e. Kairang Maning Leikai near Water Supply Tank, Imphal East District at 2:25 p.m. and seized **one mobile phone (Redmi note 12 5G) bearing IMEI No. 864398063977071/01 & 864398063977089/01 along with one Airtel SIM Card having no. 7627992030** from his possession at the spot i.e. Kairang Maning Leikai near Water Supply Tank, Imphal East District at 2:30 p.m. by observing due formalities.

On verification of the last arrestee (**Soram Abungcha Meitei**) he joined the said outfit through one Mr. Tomba of KCP - Apunba (City Meitei) in the month of August, 2023 and presently working under the command of the said Mr. Paikhomba of KCP - Apunba (City Meitei) group.

Therefore, the arrested persons along with the seized items are being handed over to you for taking up further necessary legal actions against them.
