Sir.



I have the honour to state that today i.e. 29/07/2025, based on a reliable information which was received from our own source and further corroborated from the information input provided by 33 AR regarding the presence of some active cadres of KCP organization, an outlawed banned organization in and around Nongada area of Imphal East District, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW assisted by SI. T. Shyam Singh of CDO-IW and myself under the command of Shri. P. Achouba Meetei, MPS, Dy.SP(CDO)IW and under the supervision of Shri. Gaurav Dogra, IPS, i/c Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room (Oscar-50) and conducted search operation at Nongada Awang Leikai area of Imphal East District. During that one suspected person was detained at Nongada Awang Leikai. On spot verification, the detainee identified himself as Khaidem Nongpoknganba Singh (21 yrs.) s/o Kh. Joychandra Singh of Lamlai Mayai Leikai, Imphal East District.

During preliminary verification, he disclosed that he is an active member of KCP (MFL) organization (a faction of KCP organization) and joined the said organization in July 2023 through his cousin brother Naughtyboy Khuman (Ph. No. +95 9424404518) of KCP (MFL) organization who is presently staying in Myanmar. He also disclosed that he is presently working under the command of the above mentioned Naughtyboy Khuman as his s/s Commander. Further, he disclosed that under the instruction of commander Naughtyboy Khuman, he is involved in concealing and transporting arms and ammunitions for their party. On thorough verification, he disclosed that he kept concealed a pistol in his house located at Lamlai Mayai Leikai.

Hence, he was arrested from the spot i.e., Nongada Awang Leikai at 02:00 pm and from his possession, one Redmi 13 5G mobile handset along with one Airtel SIM card bearing mobile no. 8798647958 (as disclosed by him) was seized at the spot at 02:07 pm by observing formalities.

Immediately, as a follow-up action based on the disclosure of the arrestee, our team along with him rushed to his house located at Lamlai Mayai Leikai and as pointed out by him, one 9mm pistol marked with "AUTOMATIC PISTOL 9 ROUND. LiDi MADE IN ITALY" along with one magazine was recovered at his instance which was found kept concealed under the mattress of his bed.

Hence, the above recovered pistol was seized from his residence at 02:32 pm by observing formalities.

On being asked about the above recovered pistol, he disclosed that under the instruction of his commander, he kept the said pistol to be used in their party activities. He further disclosed that he used the same pistol in an incident of firing at Napet Palli Village in the night of 10/07/2025 (probably). He further disclosed that his associate namely one Kumar of KCP (MFL) organization, who is running a workshop at Langthabal Kunja area, was also involved in concealing and transporting the above recovered pistol.

Without losing much time, as a follow-up action based on the disclosure of the arrestee, our team along with him rushed to the workshop run by his associate Kumar located at Langthabal Kunja and as pointed out by him, his associate Kumar was successfully detained at the workshop located at Langthabal Kunja. On spot verification, the detainee identified himself as Thounaojam Ashokumar Singh (43 yrs.) @ Kumar s/ o Th. Kalanjoy Singh of Leiphrakpam Mamang Leikai, Thoubal District (who later disclosed that he is running the said workshop).

During preliminary verification, he disclosed that he is an active member of KCP (MFL) organization (a faction of KCP organization) and joined the said organization in the year 2024 through his cousin brother-in-law namely Naughtyboy Khuman of KCP (MFL) organization. He also disclosed that he is presently working under the command of the above mentioned Naughtyboy Khuman as his s/s Commander. Further, he disclosed that under the instruction of his commander, he was also involved in concealing and transporting the above recovered pistol.

From his possession, the following articles were recovered:

Hence, he was arrested from the spot i.e., from the workshop located at Langthabal Kunja at 03:26 pm and the by him). above recovered articles were seized at the spot at 03:34 pm by observing formalities.

Hence, the arrested persons and the seized articles are handed over to you for taking further necessary legal action against them.
