Today i.e. 03/08/2025 at about 7:10 pm received an information that on the same day at about 7:05 pm one Vespa Scooter, Blue in colour bearing registration No. MN01AN 3718 driven by unknown person which was coming from Lamlong side towards Sawombung side collided with one Maruti 800 Red



in colour bearing red. No. MN 05 4757 coming from opposite direction at Chingarel Tejpur along NH-202 Imphal Ukhrul road due to rash and negligent driving/riding on the part of the driver/rider of both the vehicles. As a result of which the scooterist and the pillion rider of Vespa Scooter got injuries on their persons and evacuated to nearby hospital for medical treatment. Both the vehicles were also damaged.

Hence the case on Suo-Mottu under FIR No.77(8)2025, LLI-PS U/S 125/281/324 BNS has been registered for investigation.
