Sir.

I have the honour to report that today i.e. the 3<sup>rd</sup> August, 2025 at about 5:00 p.m. received a credible information from our own source about the presence of some active cadres of the outfit PREPAK at Pungdongbam Village along Lamlai Bazar of Imphal East District. Based on the said information, teams of CDO/IE Unit under the command of Inspt. N. Devdas Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)IE, rushed to the said area and conducted a random frisking and checking to the suspected passersby at Itam Thongkhong, Pungdongbam, Imphal East District at about 6:00 p.m.

In that, one unknown suspicious person was detained for spot verification and checking at Itam Thongkhong, Pungdongbam, Imphal East District. On checking the detainee body, one AADHAR card was

found and recovered from his possession. On verification, the detained identified himself as one Sorokhaibam Rohit Meitei @ Salai (24) S/o S. Ibomeha Meitei of Loushangkhong Awang Leikai, Lamlai Police Station, Imphal East District. On further verification, the detainee stated that, he is an active cadre of the outfit PREPAK, joined through one Mr. Erei of PREPAK in the month of April, 2024 and got his basic military training for ten days at Koutrouk, Imphal West District under the command of the said Mr. Erei of PREPAK. The detainee further stated that, he is presently working under the command of one s/s - Camp Commander Mr. Thangjingnganba of PREPAK.

So, the detainee was arrested from the spot i.e. Itam Thongkhong, Pungdongbam, Imphal East District at about 6:27 p.m. and seized one AADHAR card from his possession at 6:35 p.m. by observing due

Therefore, the arrested person along with the seized AADHAR card is being handed over to you for formalities. taking up further necessary legal actions against him.
