I have the honour to report that today i.e. the 4th August, 2025 at about 5:00 p.m. received a reliable Sir. information from our own source about the presence of some anti-social elements likely to carry out prejudicial activities at Pourabi Village of Imphal East District. A combined team of CDO/IE Unit and 4 AR under the command of Inspt. N. Devdas Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)IE, rushed to the said area and conducted a random frisking and checking to the

suspected passersby at Pourabi, Imphal East District at about 6:00 p.m.

In that, one suspicious unknown person coming in a scooter was detained for spot verification and checking at Pourabi Hidumbi, near Culvert Imphal East District. On checking the driver of the scooter; (i) one 9 mm Pistol with magazine, (ii) two nos. of 9 mm ammunitions, (iii) one mobile phone and (iv) one AADHAR card were found and recovered from his possession. On verification the detainee identified himself as one Ningombam Abung Meitei @ Ibomcha (50 years) S/o (Late) N. Lila Singh of Huidrom Awang Leikai, Lamlai PS, Imphal East District. On further verification, the detainee stated that he is an illegal arm-smuggler and the above recovered pistol was handed over to him by one of his associate namely Mr. Konungjao from Keibi, Impphal East for selling to the willing buyers. He further stated that, today he came to Pourabi area to sell the above recovered Pistol and ammunitions to one person at the cost of Rs. 50. 000/- (fifty thousand rupees).

So, the detainee was arrested from the spot i.e. Pourabi Hidumbi, near Culvert Imphal East District at about 6:33 p.m. and seized; (i) one 9 mm Pistol with magazine, (ii) two nos. of 9 mm ammunitions, (iii) one Scooter (Vespa), white in colour bearing regd. no. MN-01AC/0225 having Engine no. M449M3120242 & Chassis no. MET0000EATA003730, (iv) one mobile phone (Nokia) bearing IME1 no. 351068381539040 along with one Aritel SIM card bearing no. +91 8131 804853 and (v) one AADHAR card from the spot i.e. Pourabi Hidumbi, near Culvert Imphal East District at about 6:40 p.m. his

possession by observing due formalities.

On further verification of the arrestee, it came to learnt that the said Mr. Konungjao is presently staying at his residence at Keibi. Immediately, our combined team rushed to the said place and on the pointing of the arrestee, one Ningthoukhongjam Konungjao Meetei (33) S/o-(Late) N. Nimai Meetei of Keibi Khulen Makha Leikai, Sagolmang PS, Imphal East was arrested from his residence i.e. Keibi Khulen Makha Leikai, Sagolmang PS, Imphal East at 7:20 p.m. and seized one mobile phone (Redmi Note 10) bearing IMEI no. 868329050875792/21 & 868329050875800/21 along with two SIM cards bearing no. Airtel - +91 8257838311 & Jio - +91 6009522410 from his possession.

On verification of the second arrestee (Konungjao), he stated that the above recovered arms and ammunitions were handed over to him by one unknown person in the month of June, 2023 and today he

handed over the same to the first arrestee (Abung) for selling to the willing buyers.

Therefore, the arrested persons along with the seized items are being handed over to you for taking up further necessary legal actions against them.
