I have the honour to report that today i.e. the 20th August, 2025 at about 11:20 a.m. received a credible information from our own source corroborated with the intelligence of 28 AR about the presence of an active cadre of the outfit PREPAK at Sawombung area of Imphal East District. On verification, the detainee identified himself as one Sarangthem Suresh Singh @ Chinglen @ Bungo (23 years) S/o S. Chinglen Singh of Huikap Makha Leikai, Andro PS, Imphal East District. A/p- Nongpok Kakching Maning Leikai, Lamlai PS, Imphal East Disrict. On further verification, the detainee stated that he is an active cadre of the outfit PREPAK joined through one Miss. Mona Khuman of PREPAK in the month of August, 2024 and got his basic military training for 45 days under the command of one Mr. Japan of PREPAK. The detainee further stated that he is presently working under the command of one Mr. Prem of PREPAK.

So, the detainee was arrested from the spot i.e. of Sawombung Bridge, eastern side at 12:40 p.m. by observing due formalities and seized one mobile phone (Redmi 13C) bearing IMEI no. 868618079974549 & 868618079974556 along with one Jio SIM card bearing no. 60098 57024 from his possession at the spot i.e. Sawombung Bridge, eastern side at 12:45 p.m. by observing due formalities.
