Sir,

I have the honour to report that today i.e. the 23rd August, 2025 at about 12:30 p.m. received a reliable information from our own source and with the intelligence of 10 BSF about the presence of an active cadre of the outfit RPF/PLA at Sawombung — Tejpur, Imphal East District. Based on the said information and with the permission/authorization of the authority, a combined team of CDO/IE Unit and 33 AR under the command of Shri. Khumanthem Dhiraj Karan, MPS, Dy. SP(Ops)IE also looking after the charge of OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)IE rushed to the said area and conducted a searched operation at about 1:30 p.m.

In that, one unknown suspicious person was detained for spot verification at Chingarel Tejpur, Waiton Lamkhai near Oil Pump, Imphal East District. On checking the detainee body, one AADHAR card was found and recovered from his possession. On verification, the detainee identified himself as one Oinam Bungobi Meitei @ Langmei (31 years) S/o O. Loken Meitei of Ishika Awang Leikai, Sagolmang PS, Imphal East. On further verification, the detainee stated that he is an active member of the outfit RPF/PLA joined through one s/s – Lieutenant Mr. Bonex of RPF/PLA in the month of September, 2023 and got his basic military training for three months at Myothit, Myanmar under the command of one s/s – Major Mr. Loijing of RPF/PLA with

allotted army no. 3405 of 2023 bathed. The detainee further stated that he is presently holding the rank of s/s - Private and working under the command of one s/s - Captain Mr. Khaba of RPF/PLA.

So, the detainee was arrested from the spot i.e. Chingarel Tejpur, Waiton Lamkhai near Oil Pump, Imphal East District at 2:15 p.m. by observing due formalities and seized one AADHAR card from his possession at the spot i.e. Chingarel Tejpur, Waiton Lamkhai near Oil Pump, Imphal East District at 2:20 p.m. by observing due formalities

Therefore, the arrested person along with the seized AADHAR card is being handed over to you for taking up

further necessary legal actions against him.
