Subject: Urgent Criminal Complaint for Cheating, Criminal Breach of Trust, Fraud, Criminal Conspiracy, Criminal intimidation, Extortion, against Kamal Khurana and Yogesh Rathi.

Respected Sir/Madam,

l, Rahul Agarwal, on behalf of me and my brother Abhishek Aggarwal hereby file this urgent criminal complaint against Mr. Kamal Khurana and Mr. Yogesh Rathi, acting through their firm, Universal Investment Group, in collusion with Parmesh Construction Co. Ltd (Bhutani Builders) and the offence happened at 2nd Manipur Rifles Canteen Complex and falls in your territorial jurisdiction.

Criminal Offenses Committed:

In late 2020, Mr. Kamal Khurana, posing as both a builder and a channel partner, made fraudulent representations about the Bhutani Alphathum project (Tower E), Sector-90, Noida. He used deceptive promotional materials, falsely promising high returns of 24% and ownership benefits. In order to induce trust and secure investment, he personally visited Imphal, Manipur, with the intent to defraud in late 2020.

In around Oct-Nov 2020, based on these fraudulent representations, we were led to invest in five (5) units under a construction-linked payment plan in their project named Bhutani Alphathum, Tower E, Noida sector 90, UP, 201305. The accused employed deceptive tactics to secure the payments, misrepresenting the nature of the project and its promised returns.

Financial Transactions and Illegal Conduct: The entire payments were made at 2nd MR Complex Canteen in Oct-Nov, 2020.

Additionally, 2 undated cheques without name for ₹2.5 lakhs were provided along with self-attested copies of my PAN Card and Aadhaar Card to execute the Builder-Buyer Agreement (BBA) by them.


Specific Legal Offenses Committed:

Criminal Conspiracy and Common Intention:

The accused acted in concert with each other and Parmesh Construction Co. Ltd to induce fraudulent transactions, with premeditated intent to deceive, cheat, and exploit us.

Cheating, Fraud, and Misrepresentation:

We were misled into making the investment based on false promises of assured high returns and unit allocation. The project was misrepresented as having features like the world's largest infinity pool on the terrace. However, receipts for four out of the five units were never issued indicating a



Criminal Breach of Trust:

The accused misappropriated our funds, withheld necessary documents and payments, and failed to allocate the units or issue refunds, thus breaching the trust placed in them.

Forgery and Fabrication of Documents:

The accused fabricated misleading promotional material and made false representations to induce payments. They failed to issue the promised Builder-Buyer Agreement (BBA) or receipts for the payments made.

Furthermore, the undated and unnamed cheque is at risk of misuse. The accused also issued forged/fake BBA agreements and a false Letter of Intent (LOI) despite repeated requests for legitimate documentation.

It has come to our knowledge that the accused have defrauded hundreds of other buyers and that Bhutani Builders are currently under investigation by the Income Tax and Enforcement Directorate (ED) departments. Furthermore, their projects are not approved by RERA, indicating a widespread fraudulent operation targeting innocent buyers across India in a similar modus opearandi.

Criminal Intimidation and Extortion:

Upon repeated requests for a refund or unit allocation, Kamal Khurana and Yogesh Rathi issued direct threats, including the statement: "Jyada bolega to teri laash bhi nahi milegi" (If you speak too much, even your dead body won't be found). These threats were intended to suppress legal action and coerce us into silence, clearly constituting criminal intimidation and extortion.

Additionally, the accused persistently pressured us to make an additional payment to him personally and in third party accounts. Also, he is currently forcing us to transfer the units from NOIDA into a Goa-based project, demanding an additional investable amount of approximately \$\text{t}\$ crore for a project launched by him.

Please acknowledge receipt of this complaint and take immediate legal action to ensure that justice is served.
