Sir,

I have the honour to report that today i.e. the 22nd August, 2025 at about 12:20 p.m. received a reliable information from our own source and with the intelligence of 165 TA about the presence of an active member of the outfit KCP at Khongman Zone -III, Imphal East District. Based on the said information and with the permission/authorization of the authority, a combined team of CDO/IE Unit, a column of 165 TA and 33 AR under the command of Shri. Khumanthem Dhiraj Karan, MPS, Dy. SP(Ops)IE also looking after the charge of OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)IE rushed to the said area and conducted a searched operation at about 1:30 p.m.

In that, one unknown suspicious person was detained for spot verification at a house at Khongman Zone - III, Imphal-East District. On checking the detainee body, one mobile phone and one AADHAR card were found and recovered from his possession. On verification, the detainee identified himself as one **Kshetrimayum Bhogendro Singh @ Yaiphaba @ Prem (44 years) S/o - (L) Ksh. Kunjakishwor Singh of Khongman Zone - III, Irilbung PS, Imphal East District.** On further verification, the detainee stated that he is an active member of the outfit KCP (Taibangnganba) group joined through one Mr. Sharma of KCP (Taibangnganba) in the month January, 2025 and presently working under his command. The detainee further stated that he had extorted a huge amount of money from various shopkeepers and general public of Imphal-East & Imphal-West District for raising their party fund on the command and advice of the said Mr. Sharma of KCP (Taibangnganba) group.

So, the detainee was arrested from his residence i.e. **Khongman Zone - III, Irilbung PS, Imphal East District** at 2:15 p.m. by observing due formalities and seized **one mobile phone (Mi 10i) bearing IMEI No. 862384052578072/00 & 862384052578080/00 along with two Airtel SIM cards having phone nos. 8731910540 & 9774778995 and one AADHAR card** from his residence i.e. Khongman Zone - III, Irilbung PS, Imphal East District at 2:20 p.m. by observing due formalities.

Therefore, the arrested person along with the seized items are being handed over to you for taking up further necessary legal actions against him.
