Sir,

I have the honour to report that today i.e. the 23rd August, 2025 at about 3:30 p.m. received a credible information from our own source corroborated with the intelligence of Inspector Md. Rajib Khan, In-Charge Cyber Lab Unit Imphal East District about the concealment of a huge nos. of arms, ammunitions and explosives by unknown arms miscreants in general area of Uran Chiru Village and its surrounding area of Imphal-East District. Based on the said information and with the permission/authorization of the authority, a combined team of CDO/IE Unit and one team of Cyber Lab Unit, Imphal East led by ASI. Abdul Khaliq of CDO/IE attached with Cyber Lab Unit Imphal East District conducted a searched operation at the said area under the command of Shri. Khumanthem Dhiraj Karan, MPS, Dy. SP(Ops)IE also looking after the charge of OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)IE at 4:30 p.m.

During the search operation, the undernoted arms and explosives were found hidden in a bush, containing inside a white sack bag, at the foothill of Uran Chiru Village road, Imphal East District.

- 1) 1(one) AK 56 Rifle marked as '23359' with magazine.**
- 2) 1(one) AK 47 Rifle marked as 192901222' with magazine.**
- 3) 1(one) AK 47 Rifle marked as 193901266 with magazine.**
- 4) 1(one) 12 bore Single barrel gun.**
- 5) 1(one) 12 bore bauble barrel gun and**
- 6) 3(three) nos. of No. 36 Hand grenades.**

Accordingly, the above recovered arms and explosives and the white sack bag were seized at the spot i.e. foothill of Uran Chiru Village road, Imphal East District at 5:20 p.m. by observing due formalities.

Therefore, the seized items are being handed over to you for taking up further necessary legal procedures.

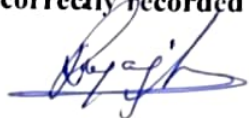
