Report:

Based on specific input received from source, an overnight operation was conducted by District Police Churachandpur in the intervening night of 22nd and 23rd July, 2025. On the 23rd of July at around 0200 Hrs, one Mr. Siamkhansuan (43) s/o (L) Ginzalal of Gouchinkhup Veng, Churachandpur was apprehended and arrested close to Singngat Police Station. As identified by the source he had partaken on a drug deal. On interrogation he revealed the location of the consignment, accordingly a team of Churachandpur Distric Police along with Executive Magistrate on duty immediately rush to the location i.e, Enpum Village, Suangdoh Sub-Division, as appointed out by the accused person namely Mr. Siamkhansuan conducted house search at the residence of Mr. Thangmaljohn @ Hunter (35) s/o Khomminthang of Enpum Village, Suangdoh Sub-Division, and during house search 10(ten) packets of suspected WY tablets labelled 999 neatly wrapped in brown paper containing approximately 1,00,000 (one lakh) tablets was recovered from his residence. The tablets contained amphetamine after testing through the Testing Kit brought by the team. The same drug WY packets were sealed and packed and seized. The owner namely Mr. Thangmaljohn @ Hunter is arresrted in the presence of Executive Magistrate and witnesses at 0330 Hrs on 23rd July, 2025

Accordingly, a Suo-Moto case under FIR No. 03(07)2025 SGT-PS u/s 22(c) ND&PS Act is registered for investigation.
