12. **First Information contents:**

The brief of the case is that Survey of India has established Continuously Operating Reference Station (CORS) a real time GNSS network throughout the state including Manipur. In Singngat CORS station is established in the premises of SDO Office, Singngat Churachandpur, Manipur. However, due to the ongoing civil unrest and violence in Manipur since May 2023, CORS was unable to visit the site for regular maintenance or inspection. On August 3, 2025, the engineer team attended the site and discovered that all equipment installed inside the enclosure box had been stolen, including the antenna mounted on top and the solar panel. Furthermore, the enclosure box itself was heavily burnt.
