Upon checking the Bolero, 111 soap cases weighing about 4.945 kg. approx (including plastic and soap cases) containing suspected brown sugar was recovered from the bonnet of the Bolero. The apprehended persons as well as the seized items were taken to SGT-PS and handed over to OC/SGT-PS for taking further necessary action.
